The applicant **TIMOTHY O. TUCKER AND THE ESTATE OF SCOTT B. (BRIAN) TUCKER** hereby makeS application for permission to change the **POINT OF DIVERSION, PLACE OF USE AND MANNER OF USE OF A PORTION** of water heretofore appropriated under **PERMIT 59873**

1. The source of water is **UNDERGROUND**
2. The amount of water to be changed **0.0001 CFS NOT TO EXCEED 0.050 ACRE FEET ANNUALLY**
3. The water to be used for **RECREATION (GOLF COURSE IRRIGATION)**
4. The water heretofore permitted for **MUNICIPAL**
5. The water is to be diverted at the following point **LOT 4, SECTION 7, T.20N.; R.21E., M.D.B.&M. OR AT A POINT FROM WHICH THE SOUTHWEST CORNER OF SAID SECTION 7 BEARS S.19° 00' 00" W. A DISTANCE OF 270.0 FEET.**
