The applicant **George W. Gillemot, Trustee of the Gillemot Family Trust** dated **December 14, 1984.**, hereby makes application for permission to change the **Point of Diversion, Manner of Use and Place of Use of a portion.** of water heretofore appropriated under **Permit 61629**

1. The source of water is **Underground**
2. The amount of water to be changed **5.92 acre-feet annually; 0.0082 c.f.s.**
3. The water to be used for **irrigation**

5. The water is to be diverted at the following point **within NW¼ NE¼ Section 10, Township 16 North, Range 19 East, M.D.B.&M., North 75°00' West, 2800 feet NW to corner of said Section 10.**

APPROVAL OF STATE ENGINEER

This is to certify that I have examined the foregoing application, and do hereby grant the same, subject to the following limitations and conditions:

This permit to change the point of diversion, place of use and manner of use of a portion of the waters of an underground source as heretofore granted under Permit 61629 is issued subject to the terms and conditions imposed in said Permit 61629 and with the understanding that no other rights on the source will be affected by the change proposed herein. The well shall be equipped with a 2-inch opening and a totalizing meter must be installed and maintained in the discharge pipeline near the point of diversion and accurate measurements must be kept of water placed to beneficial use. The totalizing meter must be installed before any use of the water begins or before the proof of completion of work is filed. If the well is flowing, a valve must be installed and maintained to prevent waste. This source is located within an area designated by the State Engineer pursuant to NRS 534.030. The State retains the right to regulate the use of the water herein granted at any and all times.

This permit does not extend the permittee the right of ingress and egress on public, private or corporate lands.

The total combined duty of water under Permits 70431, 70432, 70433 and 70434 shall not exceed 60 acre-feet annually.

The issuance of this permit does not waive the requirements that the permit holder obtain other permits from State, Federal and local agencies.

With the issuance of Permits 70431, 70432, 70433, and 70434, the total combined duty of Permits 61627, 61628, 61629, 61724 and 62348 is reduced to 216.66 acre-feet annually.

This permit is issued for the irrigation of 15 acres within the described place of use.

The amount of water to be appropriated shall be limited to the amount which can be applied to beneficial use, and not to exceed 0.0082 cubic feet per second, but not to exceed 5.92 acre-feet annually and not to exceed a yearly duty of 4.0 acre-feet per acre of land irrigated from any and/or all sources.
