The applicant **Bonnie Wahl** hereby makes application for permission to change the **Point of Diversion and Place of Use** of water heretofore appropriated under **Permit #28828, Certificate #10665**

1. The source of water is **an underground source**
2. The amount of water to be changed **65.7 acre feet**
3. The water to be used for **irrigation and domestic use**
4. The water heretofore permitted for **irrigation and domestic use**
5. The water is to be diverted at the following point **within the SE $\frac{1}{4}$ NW $\frac{1}{4}$ Section 35, Township 16 South, Range 49 East, M.D.B.&M at a point that bears North 54° East, 94.0 feet to the Northeast corner of the SE $\frac{1}{4}$ NW $\frac{1}{4}$ of said Section 35 (i.e., the replacement well)**
6. The existing permitted point of diversion is located within **the SE $\frac{1}{4}$ NW $\frac{1}{4}$ Section 35, Township 16 South, Range 49 East, M.D.B.&M. at a point that bears North 45° East, 77.78 feet to the Northeast corner of the SE $\frac{1}{4}$ NW $\frac{1}{4}$ of said Section 35.**
7. Proposed place of use **28.14 acres within the SE $\frac{1}{4}$ NW $\frac{1}{4}$ and the SW $\frac{1}{4}$ NE $\frac{1}{4}$ of Section 35, Township 16 South, Range 49 East, M.D.B.&M.**
8. Existing place of use **13.14 acres within the SE $\frac{1}{4}$ NW $\frac{1}{4}$ and the SW $\frac{1}{4}$ NE $\frac{1}{4}$ of Section 35, Township 16 South, Range 49 East, M.D.B.&M.**
9. Use will be from **January 1st to December 31st** of each year.
10. Use was permitted from **January 1st to December 31st** of each year.
11. Description of proposed works **Well, pump, pressure tanks, and distribution pipelines.**
12. Estimated cost of works **\$15,000.00**
13. Estimated time required to construct works **One (1) year**
14. Estimated time required to complete the application of water to beneficial use **Two (2) years**
15. Remarks: **Water is to be co-mingled with Permit Nos. 68741, 68742 and 68743.**

APPROVAL OF STATE ENGINEER

This is to certify that I have examined the foregoing application, and do hereby grant the same, subject to the following limitations and conditions:

This permit to change the point of diversion and place of use of the waters of an underground source as heretofore granted under Permit 28828, Certificate 10665, is issued subject to the terms and conditions imposed in said Permit 28828, Certificate 10665, and with the understanding that no other rights on the source will be affected by the change proposed herein. The well shall be equipped with a 2-inch opening and a totalizing meter must be installed and maintained in the discharge pipeline near the point of diversion and accurate measurements must be kept of water placed to beneficial use. The totalizing meter must be installed before any use of the water begins or before the proof of completion of work is filed. If the well is flowing, a valve must be installed and maintained to prevent waste. This source is located within an area designated by the State Engineer pursuant to NRS 534.030. The State retains the right to regulate the use of the water herein granted at any and all times.

This permit does not extend the permittee the right of ingress and egress on public, private or corporate lands.

The total combined duty of water under Permits 70715, 70716, 70717 and 70718 shall not exceed 125.70 acre-feet annually for the irrigation of 28.14.

The issuance of this permit does not waive the requirements that the permit holder obtain other permits from State, Federal and local agencies.

If any water under this permit is cancelled, withdrawn, or any water is not put to beneficial use, it will revert to the groundwater source and not back to the base water right.

The amount of water to be appropriated shall be limited to the amount which can be applied to beneficial use, and not to exceed 0.43 cubic feet per second, but not to exceed 65.7 acre-feet annually, and not to exceed a yearly duty of 5.0 acre-feet per acre of land irrigated from any and/or all sources.

Work must be prosecuted with reasonable diligence and be completed on or before:

July 6, 2005

Proof of completion of work shall be filed on or before:

August 6, 2005

Water must be placed to beneficial use on or before:

July 6, 2008

Proof of the application of water to beneficial use shall be filed on or before:

August 6, 2008


