This is to certify that I have examined the foregoing application, and do hereby grant the same, subject to the following limitations and conditions:

This permit is issued subject to all existing rights on the source. It is understood that the amount of water herein granted is only a temporary allowance and that the final water right obtained under this permit will be dependent upon the period of use and the average number of livestock served from the waters of this source.

This permit does not extend the permittee the right of ingress and egress on public, private or corporate lands.

The issuance of this permit does not waive the requirements that the permit holder obtain other permits from State, Federal and local agencies.

The point of diversion and place of use are as described on the submitted application to support this permit.

The amount of water to be appropriated shall be limited to the amount which can be applied to beneficial use, and not to exceed 0.03 cubic feet per second or sufficient to water 2000 sheep and 500 cattle but not to exceed or 14.42 acre-feet seasonally.

Work must be prosecuted with reasonable diligence and proof of completion of work shall be filed on or before:

December 31, 2009

Water must be placed to beneficial use and proof of the application of water to beneficial use shall be filed on or before:

December 31, 2012

The applicant **Estill Ranches L.L.C.** hereby make application for permission to appropriate the public waters of the State of Nevada, as hereinafter stated. (If applicant is a corporation, give date and place of incorporation; if a copartnership or association give names of members.)

1. The source of the proposed appropriation is **underground**
2. The amount of water applied for is **0.03** second-feet
 - (a) If stored in reservoir give number of acre-feet
3. The water to be used for **Stockwater, Domestic**

5. The water is to be diverted from its source at the following point **SW¼ SE¼ of Section 23, T36N R19E, M.D.B.M., at a point from which the SE corner of said Section bears S 77°E, a distance of 1,900 feet.**
6. Place of Use **Deeded lands. SW¼ SE¼ Section 23, T36N, R19E, M.D.B.M.**
7. Use will begin about **March 15th** and end about **Nov. 30th** of each year.
8. Description of proposed works **Drilled well w/pump and motor, pipelines and storage facilities**
9. Estimated cost of works **\$25,000**
10. Estimated time required to construct works **5 years**
11. Estimated time required to complete the application of water to beneficial use **5 years**
12. Remarks: **This application is the same as Application 50220 which was denied by the State Engineer. It is different in that the beneficial use is stock watering and the place of use is the BLM Range Allotment owned by the applicant.**
