The applicant **James R. Boyce**, hereby makes application for permission to change the **Manner & Place of Use** of water heretofore appropriated under **Permit 25314, Certificate 8171**

1. The source of water is **underground (CR-3 Well)**
2. The amount of water to be changed **1.42 c.f.s., not to exceed 640 acre-feet annually**
3. The water to be used for **Irrigation**
4. The water heretofore permitted for **Irrigation & domestic**
5. The water is to be diverted at the following point **NW¼ SW¼, Section 15, T.3S., R.35E., M.D.B.&M., or at a point from which the SW Corner of said Section 15 bears S 12°17' W., a distance of 2463.82 feet. See map filed under Permit 25314.**
6. The existing permitted point of diversion is located within **Unchanged**
7. Proposed place of use **See Attachment "A"**
8. Existing place of use **See Attachment "B"**
9. Use will be from **January 1 to December 31** of each year.
10. Use was permitted from **January 1 to December 31** of each year.
11. Description of proposed works **Existing drilled and cased well equipped with a motor and pump then through a distribution system to the place of use.**
12. Estimated cost of works **\$75,000.00**
13. Estimated time required to construct works **Well completed**
14. Estimated time required to complete the application of water to beneficial use **Five (5) years**
15. Remarks: **Applications to Change Proof 01344 and Permits 5201, 13973, 25313, 25314, 25315, 25316, 27992 and 31284 are being filed to co-mingle the duties within a common place of use. The duty of these applications will not exceed 5 acre-feet per acre from any and all sources. These applications are being filed in compliance with the State Engineer's ruling associated with the reinstatement of Permits 44540, et.al.**

APPROVAL OF STATE ENGINEER

This is to certify that I have examined the foregoing application, and do hereby grant the same, subject to the following limitations and conditions:

This permit to change the place of use and manner of use of the waters of an underground source as heretofore granted under Permit 25314, Certificate 8171 is issued subject to the terms and conditions imposed in said Permit 25314, Certificate 8171 and with the understanding that no other rights on the source will be affected by the change proposed herein. The well shall be equipped with a 2-inch opening and a totalizing meter must be installed and maintained in the discharge pipeline near the point of diversion and accurate measurements must be kept of water placed to beneficial use. The totalizing meter must be installed before any use of the water begins or before the proof of completion of work is filed. If the well is flowing, a valve must be installed and maintained to prevent waste. This source is located within an area designated by the State Engineer pursuant to NRS 534.030. The State retains the right to regulate the use of the water herein granted at any and all times.

This permit does not extend the permittee the right of ingress and egress on public, private or corporate lands.

The issuance of this permit does not waive the requirements that the permit holder obtain other permits from State, Federal and local agencies.

Monthly records shall be kept of the amount of water pumped from this well and the records submitted to the State Engineer on February 15th of each year.

The total acres irrigated on the center portion of the ranch by Permits 70834 through 70842, shall be limited to 1,462.47 acres from surface sources, plus 341.9 acres from non-supplemental underground sources, for a total of 1,804.37 acres irrigated from all sources within the common described place of use.

The total combined duty of underground water on the center portion of the ranch under Permits 70836 through 70842 shall be limited to 1,709.50 acre-feet annually (AFA) for non-supplemental underground water, plus 3,551.30 AFA for supplemental underground water, for a maximum total combined duty of underground water of 5,260.80 AFA.

The total combined diversion rate and duty of the well containing Permits 70837 and 70838 shall be limited to 2.53 CFS and 1280.00 AFA, respectively.

The amount of water to be appropriated shall be limited to the amount which can be applied to beneficial use, and not to exceed 1.42 cubic feet per second, **but not to exceed 640.0 acre-feet annually, and not to exceed a yearly duty of 5.0 acre-feet per acre of land irrigated from any and/or all sources.**

Work must be prosecuted with reasonable diligence and be completed on or before:

January 12, 2007

Proof of completion of work shall be filed before:

February 12, 2007

Water must be placed to beneficial use on or before:

January 12, 2011

Proof of the application of water to beneficial use shall be filed on or before:

February 12, 2011

Map in support of proof of beneficial use shall be filed on or before:

February 12, 2011
