The applicant **Truckee Meadows Water Authority**, hereby makes application for permission to change the **Point of Diversion and Manner of Use of a portion** water heretofore appropriated under **Permit No. 66959**

1. The source of water is **Underground**
2. The amount of water to be changed **0.0667 cfs but not to exceed 25.00 acre feet annually**
3. The water to be used for **Construction Water**
4. The water heretofore permitted for **Municipal**
5. The water is to be diverted at the following point **Situate in the NE¹/₄ SW¹/₄ of Section 18, T. 21N., R. 19E., M.D.M., Or from the point of diversion the southwest corner of said Section 18 bears South 49° 21' 31" West, a distance of 2018.40 feet (Silver Knolls Well), (actual) The POD is described in Permit No. 24788 (RECORD TIE S 49° 21' W, A DISTANCE OF 2018.2 FEET).**
6. The existing permitted point of diversion is located within **the SE¹/₄ NW¹/₄ of Section 30, T. 21N., R. 19E., M.D.B.&M., or at a point from which the west ¹/₄ corner of said Section 30 bears South 75° 00'00" West, a distance of 1,900 feet.**
7. Proposed place of use **Please refer to Exhibit "A" attached.**
8. Existing place of use **Please refer to Exhibit "A" attached.**
9. Use will be from **January 1 to December 31** of each year.
10. Use was permitted from **January 1 to December 31** of each year.
11. Description of proposed works **Water to be pumped from well, equipped with motor and Pump, and used as construction water**
12. Estimated cost of works **\$25,000**
13. Estimated time required to construct works **One (1) year**
14. Estimated time required to complete the application of water to beneficial use **One (1) year**
15. Remarks: **The water to be pumped is for construction water at the Stead airport for re-construction of the runways. Hamilton Properties, Inc. has authorized TMWA to move this**

water for a period of one (1) year. The total combined duty of this Temp Application and Temp Application No. 70872-T shall not exceed 25.00 AFA.

APPROVAL OF STATE ENGINEER

This is to certify that I have examined the foregoing application, and do hereby grant the same, subject to the following limitations and conditions:

This temporary permit to change the point of diversion and manner of use of a portion of the waters of an underground source as heretofore granted under Permit 66959 is issued subject to the terms and conditions imposed in said Permit 66959 and with the understanding that no other rights on the source will be affected by the change proposed herein. The well shall be equipped with a 2-inch opening and a totalizing meter must be installed and maintained in the discharge pipeline near the point of diversion and accurate measurements must be kept of water placed to beneficial use. The totalizing meter must be installed before any use of the water begins or before the proof of completion of work is filed. If the well is flowing, a valve must be installed and maintained to prevent waste. This source is located within an area designated by the State Engineer pursuant to NRS 534.030. The State retains the right to regulate the use of the water herein granted at any and all times.

This temporary permit does not extend the permittee the right of ingress and egress on public, private or corporate lands.

The total combined duty of water under Permits 70871-T and 70872-T shall not exceed 25 acre-feet annually.

The issuance of this temporary permit does not waive the requirements that the permit holder obtain other permits from State, Federal and local agencies.

This temporary permit is issued pursuant to the provisions of NRS 533.345 Section 2 and will expire on **December 31, 2004** at which time all rights herein granted shall revert to the right being changed by this temporary permit.

The amount of water to be appropriated shall be limited to the amount which can be applied to beneficial use, and not to exceed 0.0667 cubic feet per second, but not to exceed 25 acre-feet annually.
