WATERS OF THE STATE OF NEVADA**

The applicant **Joseph DeAndrea & Sone Gina** hereby make application for permission to appropriate the public waters of the State of Nevada, as hereinafter stated. (If applicant is a corporation, give date and place of incorporation; if a copartnership or association give names of members.)

1. The source of the proposed appropriation is **Underground Source**
2. The amount of water applied for is **1 Acre foot second-feet**
 - (a) If stored in reservoir give number of acre-feet
3. The water to be used for **Commercial Use**
4. If use is for:
 - (a) Irrigation, state number of acres to be irrigated
 - (b) Stockwater, state number and kinds of animals to be watered
 - (c) Other use (describe fully under No. 12. "Remarks") **Decorative rock sales**
 - (d) Power:
 - (1) Horsepower developed
 - (2) Point of return of water to stream
5. The water is to be diverted from its source at the following point **within the NW4 SW4 Section 18, Township 21 South, Range 54 East M.D.B.&M. or at a point from which the West ¼ Corner of said section 18 bears N 45°08'00" W a distance of 256.00 feet.**
6. Place of Use **within the NW4 NW4 SW4 Section 18, Township 21 South, Range 54 East M.D.B.&M. also being lot 2 of parcel map file #163877 Nye County Nevada.**
7. Use will begin about **January 1** and end about **December 31** of each year.
8. Description of proposed works **8" well, pump, pressure tank and plastic service lines.**
9. Estimated cost of works **\$2,000.00**
10. Estimated time required to construct works **2 years existing 8" well, motor, pump and service lines**
11. Estimated time required to complete the application of water to beneficial use **4 years**
12. Remarks: **Decorative rock sales, office, lawn, plants and dust control**

APPROVAL OF STATE ENGINEER

This is to certify that I have examined the foregoing application, and do hereby grant the same, subject to the following limitations and conditions:

This permit is issued subject to existing rights. It is understood that the amount of water herein granted is only a temporary allowance and that the final water right obtained under this permit will be dependent upon the amount of water actually placed to beneficial use. It is also understood that this right must allow for a reasonable lowering of the static water level. This well shall be equipped with a two (2) inch opening for measuring depth to water. If the well is flowing, a valve must be installed and maintained to prevent waste. A totalizing meter must be installed and maintained in the discharge pipeline near the point of diversion and accurate measurements must be kept of water placed to beneficial use. The totalizing meter must be installed before any use of water begins, or before the Proof of Completion of Work is filed. This source is located within an area designated by the State Engineer, pursuant to NRS 534.030. The State retains the right to regulate the use of the water herein granted at any and all times.

This permit does not extend the permittee the right of ingress and egress on public, private or corporate lands.

The issuance of this permit does not waive the requirements that the permit holder obtain other permits from State, Federal and local agencies.

This permit is issued under the provisions of NRS 534.120(2) as a preferred use.

Permit 71017 is granted to provide water service to two lots described as Nye County Assessor's Parcel Number (APN) 45-201-62 and 63.

Upon cessation of pumping for commercial purposes at this place of use, water under this permit shall return to the source and no application to change or relinquishment will be allowed.

The amount of water to be appropriated shall be limited to the amount which can be applied to beneficial use, and not to exceed 0.10 cubic feet per second, **but not to exceed 0.25 acre-feet annually.**

Work must be prosecuted with reasonable diligence and be completed on or before:

December 2, 2006

Proof of completion of work shall be filed on or before:

January 2, 2007

Water must be placed to beneficial use on or before:

December 2, 2008

Proof of the application of water to beneficial use shall be filed on or before:

January 2, 2009

Map in support of proof of beneficial use shall be filed on or before:


