The applicant Donald H. and or Beverly J. Grady, hereby make application for permission to change the the Point of Diversion and Place of use of a portion of water heretofore appropriated under Permit No. 33055, Certificate No. 13469

2. The amount of water to be changed 7.5 Acre-feet
3. The water to be used for Irrigation and Domestic

6. The existing permitted point of diversion is located within NE 1/4 NW 1/4 Sec 27, T.14S., R.66E., M.D.M., whence the NE Cor. of said Sec. 27 bears N. 69 43'46" E., a distance of 3043.48 feet.
7. Proposed place of use NE 1/4 NW 1/4 and the NW 1/4 NW 1/4, Sec. 2, T.15S., R.66E., M.D.M.
8. Existing place of use NE 1/4 NW 1/4, Sec. 27. T14S., R.66E., M.D.M. Stripping 1.5 acres as shown on supporting map
9. Use will be from January 01 to December 31 of each year.
10. Use was permitted from January 01 to December 31 of each year.
11. Description of proposed works Use existing well and irrigate field with hand lines.

APPROVAL OF STATE ENGINEER

This is to certify that I have examined the foregoing application, and do hereby grant the same, subject to the following limitations and conditions:

This permit to change the point of diversion and place of use of a portion of the waters of an underground source as heretofore granted under Permit 33055, Certificate 13469, is issued subject to the terms and conditions imposed in said Permit 33055, Certificate 13469, and with the understanding that no other rights on the source will be affected by the change proposed herein. The well shall be equipped with a 2-inch opening and a totalizing meter must be installed and maintained in the discharge pipeline near the point of diversion and accurate measurements must be kept of water placed to beneficial use. The totalizing meter must be installed before any use of the water begins or before the proof of completion of work is filed. If the well is flowing, a valve must be installed and maintained to prevent waste. This source is located within an area designated by the State Engineer pursuant to NRS 534.030. The State retains the right to regulate the use of the water herein granted at any and all times.

This permit does not extend the permittee the right of ingress and egress on public, private or corporate lands.

The well must be sealed with cement grout, concrete grout or neat cement from ground level to 100 feet.

The total combined duty of water under Permit 62874, Certificate 15428; and Permit 71024 shall not exceed 12.5 acre-feet annually.

The issuance of this permit does not waive the requirements that the permit holder obtain other permits from State, Federal and local agencies.

Permit 62874, Certificate 15428, and Permit 71024 are issued for the irrigation of 2.5 acres within described place of use.

The amount of water to be changed shall be limited to the amount which can be applied to beneficial use, and not to exceed 0.0484 cubic feet per second, **but not to exceed 7.5 acre-feet annually, and not to exceed a yearly duty of 5.0 acre-feet per acre of land irrigated from any and/or all sources.**

Work must be prosecuted with reasonable diligence and be completed on or before:
