The applicant **THE FOOTHILLS AT WINGFIELD, LLC** hereby makeS application for permission to change the **POINT OF DIVERSION OF A PORTION** of water heretofore appropriated under **PERMIT 59873**

1. The source of water is **UNDERGROUND**
2. The amount of water to be changed **0.0001 CFS NOT TO EXCEED 0.050 ACRE FEET ANNUALLY**
3. The water to be used for **MUNICIPAL**
4. The water heretofore permitted for **MUNICIPAL**
5. The water is to be diverted at the following point **LOT 4, SECTION 7, T.20N., R.21E., M.D.B.&M. OR AT A POINT FROM WHICH THE SOUTHWEST CORNER OF SAID SECTION 7 BEARS S. 19°00'00" W. A DISTANCE OF 270.0 FEET.**
6. The existing permitted point of diversion is located within **LOT 5, SECTION 6, T.20N., R.21E., M.D.B.&M. OR AT A POINT FROM WHICH THE SOUTHWEST CORNER OF SAID SECTION 6 BEARS S. 14°32' W. A DISTANCE OF 1659.1 FEET.**
7. Proposed place of use **SEE EXHIBIT "A" ATTACHED HERETO AND MAP ON FILE WITH STATE ENGINEER UNDER PERMIT 59343.**
8. Existing place of use **NO CHANGE - SEE EXHIBIT "A" ATTACHED HERETO.**
9. Use will be from **JANUARY 1 to DECEMBER 31** of each year.
10. Use was permitted from **JANUARY 1 to DECEMBER 31** of each year.
11. Description of proposed works **WATER WILL BE DIVERTED FROM EXISTING WELL, PUMP AND MOTOR INTO EXISTING TMWA DISTRIBUTION SYSTEM.**

APPROVAL OF STATE ENGINEER

This is to certify that I have examined the foregoing application, and do hereby grant the same, subject to the following limitations and conditions:

This permit to change the point of diversion of a portion of the waters of an underground source as heretofore granted under Permit 59873 is issued subject to the terms and conditions imposed in said Permit 59873 and with the understanding that no other rights on the source will be affected by the change proposed herein. The well shall be equipped with a 2-inch opening and a totalizing meter must be installed and maintained in the discharge pipeline near the point of diversion and accurate measurements must be kept of water placed to beneficial use. The totalizing meter must be installed before any use of the water begins or before the proof of completion of work is filed. If the well is flowing, a valve must be installed and maintained to prevent waste. This source is located within an area designated by the State Engineer pursuant to NRS 534.030. The State retains the right to regulate the use of the water herein granted at any and all times.

This permit does not extend the permittee the right of ingress and egress on public, private or corporate lands.

The total combined duty of water under Permits 59346, 59347, 59873, 71143, 71144 and 71145 shall not exceed 171.45 acre-feet annually.

The issuance of this permit does not waive the requirements that the permit holder obtain other permits from State, Federal and local agencies.

Monthly records shall be kept of the amount of water pumped from this well and the records submitted to the State Engineer on a quarterly basis within 15 days after the end of each calendar quarter.

If any water under this permit is cancelled, withdrawn, or any water is not put to beneficial use, it will revert to the groundwater source and not back to the base water right.

The amount of water to be changed shall be limited to the amount which can be applied to beneficial use, and not to exceed 0.0001 cubic feet per second, **but not to exceed 0.05 acre-feet annually.**

Work must be prosecuted with reasonable diligence and be completed on or before:

June 30, 2006

Proof of completion of work shall be filed on or before:

July 30, 2006

Water must be placed to beneficial use on or before:

June 30, 2011

Proof of the application of water to beneficial use shall be filed on or before:

July 30, 2011


