The applicant **Faccinto Jr. Family Trust, Albert Faccinto Jr. and Kathie A. Faccinto, Trustees** hereby make application for permission to change the **Point of Diversion and place of use of a portion** of water heretofore appropriated under **Permit 64851**

1. The source of water is **Las Vegas Artesian Basin – Underground**
2. The amount of water to be changed **Total of 0.01926CFS (2 acre feet)**
3. The water to be used for **Quasi Municipal**
4. The water heretofore permitted for **Quasi Municipal and Domestic**
5. The water is to be diverted at the following point **SW¼ NE¼ Section 31, T19S, R60E, Clark County, Nevada. The well bears S 03° 10' 10" W, 844.82 feet to the center quarter corner of said section 31. Map for 69118 filed 8-29-02.**

APPROVAL OF STATE ENGINEER

This is to certify that I have examined the foregoing application, and do hereby grant the same, subject to the following limitations and conditions:

This permit to change the point of diversion and place of use of a portion of the waters of an underground source as heretofore granted under Permit 64851 is issued subject to the terms and conditions imposed in said Permit 64851 and with the understanding that no other rights on the source will be affected by the change proposed herein. The well shall be equipped with a 2-inch opening and a totalizing meter must be installed and maintained in the discharge pipeline near the point of diversion and accurate measurements must be kept of water placed to beneficial use. The totalizing meter must be installed before any use of the water begins or before the proof of completion of work is filed. If the well is flowing, a valve must be installed and maintained to prevent waste. This source is located within an area designated by the State Engineer pursuant to NRS 534.030. The State retains the right to regulate the use of the water herein granted at any and all times.

This permit does not extend the permittee the right of ingress and egress on public, private or corporate lands.

The issuance of this permit does not waive the requirements that the permit holder obtain other permits from State, Federal and local agencies.

The total combined duty of water under Permits 69118, 70879 and 71370 shall not exceed 6.9975 acre-feet annually.

Permit 71370 is granted to provide quasi-municipal water service to four lots at a parcel described as Clark County Assessor's Parcel (APN) 125-31-601-038.
