The applicant **White Pine County** hereby makes application for permission to change the **Point of Diversion and Place of Use** of water heretofore appropriated under **Permit No. 25900 and Certificate No. 7799 Permit No. 25900 was certificated as a change to Permit No. 25025**

1. The source of water is **Underground**
2. The amount of water to be changed **0.78 cfs**
3. The water to be used for **Quasi-Municipal**
4. The water heretofore permitted for **Quasi-Municipal**
5. The water is to be diverted at the following point **In the SE $\frac{1}{4}$  NW $\frac{1}{4}$  SE $\frac{1}{4}$  of Section 15, T.17N., R.63E., M.D.B. & M. or at a point from which the SE corner of said Section 15 bears S.45°15'18"E., a distance of 2,363.39 feet.**
6. The existing permitted point of diversion is located within **the NE $\frac{1}{4}$  NW $\frac{1}{4}$  Section 36, T. 17 N., R.63 E., M.D.B. & M., or at a point from which the SW corner of said Section 36 bears S.27°10'W., a distance of 4,495 feet.**
7. Proposed place of use **All of T.17 N., R.63 E., M.D.B. & M., The East half of T. 18 N., R.62 E., M.D.B. & M. and the West half of T. 18 N., R.63 E., M.D. B. & M.**
8. Existing place of use **Portions of the NE $\frac{1}{4}$  NW $\frac{1}{4}$ , SE $\frac{1}{4}$  NW $\frac{1}{4}$  of Section 36, T. 17N., R.63 E, M.D.B.&M.**
9. Use will be from **January 1 to December 31** of each year.
10. Use was permitted from **January 1 to December 31** of each year.
11. Description of proposed works **A well will be drilled and the water into a pipeline which will provide water for the Lackawanna Fire Station for fire protection and other municipal needs of White Pine County.**
12. Estimated cost of works **\$60,000.00**
13. Estimated time required to construct works **2 Years**
14. Estimated time required to complete the application of water to beneficial use **6 year**

## APPROVAL OF STATE ENGINEER

This is to certify that I have examined the foregoing application, and do hereby grant the same, subject to the following limitations and conditions:

This permit to change the point of diversion and place of use of the waters of an underground source as heretofore granted under Permit 25900, Certificate 7799 is issued subject to the terms and conditions imposed in said Permit 25900, Certificate 7799 and with the understanding that no other rights on the source will be affected by the change proposed herein. The well shall be equipped with a 2-inch opening and a totalizing meter must be installed and maintained in the discharge pipeline near the point of diversion and accurate measurements must be kept of water placed to beneficial use. The totalizing meter must be installed before any use of the water begins or before the proof of completion of work is filed. If the well is flowing, a valve must be installed and maintained to prevent waste. This source is located within an area designated by the State Engineer pursuant to NRS 534.030. The State retains the right to regulate the use of the water herein granted at any and all times.

This permit does not extend the permittee the right of ingress and egress on public, private or corporate lands.

The issuance of this permit does not waive the requirements that the permit holder obtain other permits from State, Federal and local agencies.

The permittee shall report to the State Engineer on an annual basis the effect of pumping the well under this permit on other existing wells that are located within 2,500 feet of the well under this permit.

Any pumping of water under this permit may be limited or prohibited to prevent any unreasonable adverse effects on any existing domestic well located within 2,500 feet of the well under this permit, unless the holder of this permit and the owner of the domestic well have agreed to alternative measures that mitigate adverse effects.

Monthly records shall be kept of the amount of water pumped from this well and the records submitted to the State Engineer by February 15th of each year.

Water levels shall be taken on a monthly basis from the well originally drilled under cancelled Permit 52694 and submitted with the annual pumpage report.

(PERMIT TERMS CONTINUED)

The amount of water to be changed shall be limited to the amount which can be applied to beneficial use, and not to exceed 0.0254 cubic feet per second, **but not to exceed 6.0 million gallons annually.**

Work must be prosecuted with reasonable diligence and be completed on or before:

**June 15, 2006**

Proof of completion of work shall be filed on or before:

**July 15, 2006**

Water must be placed to beneficial use on or before:

**June 15, 2008**

Proof of the application of water to beneficial use shall be filed on or before:

**July 15, 2008**

Map in support of proof of beneficial use shall be filed on or before:
