The applicant **Lincoln County and Vidler Water Company, Inc.**, hereby make application for permission to change the **Manner of Use and Place of Use** of water heretofore appropriated under **Application Number 64689**

1. The source of water is **Underground**
2. The amount of water to be changed **10.0 cfs**
3. The water to be used for **Municipal**
4. The water heretofore permitted for **Irrigation**
5. The water is to be diverted at the following point **On unsurveyed ground within the SE $\frac{1}{4}$ SW $\frac{1}{4}$ Sec. 31, T.9S., R.65E., M.D.B.&M., or at a point from which the SW corner of Section 35, T.8S., R.65E., M.D.B.&M. bears N. 32° 24' E., a distance of 37,144 feet.**
6. The existing permitted point of diversion is located within **Same as #5**
7. Proposed place of use **Within the Coyote Springs Valley Hydrographic Basin (210) (see attached sheet)**
8. Existing place of use **On unsurveyed ground within Section 36 T.9S., R.64E., M.D.B.&M., and those portions of Sections 31, T.9S., R.65E., M.D.B.&M., Section 1, T.10S., R.64E., M.D.B.&M., and Sections 6, T.10S., R.65E., M.D.B.&M., lying westerly of the existing gravel road which is shown on the supporting map. Irrigation will be limited to 1280 acres within the proposed Place of Use.**
9. Use will be from **January 1 to December 31** of each year.
10. Use was permitted from **January 1 to December 31** of each year.
11. Description of proposed works **a drill and cased well, equipped with pump, motor, and pipeline to proposed place of use.**
