The applicant **Frehner Construction Company, Inc.**, hereby make(s) application for permission to change the **Point of diversion, Place of use, Manner of use of a portion of water** heretofore appropriated under see attached exhibit "A" as amended

1. The source of water is **underground**
2. The amount of water to be changed **34.97 acre-feet, 4.83 acres**
3. The water to be used for **mining & milling**
4. The water heretofore permitted for **irrigation**
5. The water is to be diverted at the following point **within the NE $\frac{1}{4}$ NW $\frac{1}{4}$ of section 24 T23S R60E MDM or a point from which the North $\frac{1}{4}$ corner of said section 24 bears South 26° 59' 25" West a distance of 466.67 feet. Amended map enclosed. see also permit #54172**
6. The existing permitted point of diversion is located within a **portion of the NW $\frac{1}{4}$ NW $\frac{1}{4}$ of Section 3, T21S R62E, MDB&M or a point from which the NW corner of said section 3 bears North 62° 54' 29" West a distance of 171.24 feet.**
7. Proposed place of use **see attached exhibit "B"**
8. Existing place of use **a portion of the NW $\frac{1}{4}$ of section 3, T21S R62E MDB&M. The acreage to be removed from irrigation is 4.83. Amended map enclosed.**
9. Use will be from **January 1 to December 31** of each year.
10. Use was permitted from **January 1 to December 31** of each year.
11. Description of proposed works **works completed, permit #54172**
12. Estimated cost of works **works completed, permit #54172**
13. Estimated time required to construct works **works completed, permit #54172**
14. Estimated time required to complete the application of water to beneficial use **1 year**
15. Remarks: **This application is being submitted to supplement existing water rights owned by Frehner Construction Co., Inc. at the existing POD described in item #5. The combined duty under this application and application filed to change the supplemental right 12811 shall not exceed 35.0 AC-FT.**

APPROVAL OF STATE ENGINEER

This is to certify that I have examined the foregoing application, and do hereby grant the same, subject to the following limitations and conditions:

This permit to change the point of diversion, place of use and manner of use of a portion of the waters of an underground source as heretofore granted under Proof V07656 is issued subject to the terms and conditions imposed in said Proof V07656 and with the understanding that no other rights on the source will be affected by the change proposed herein. The well shall be equipped with a 2-inch opening and a totalizing meter must be installed and maintained in the discharge pipeline near the point of diversion and accurate measurements must be kept of water placed to beneficial use. The totalizing meter must be installed before any use of the water begins or before the proof of completion of work is filed. If the well is flowing, a valve must be installed and maintained to prevent waste. This source is located within an area designated by the State Engineer pursuant to NRS 534.030. The State retains the right to regulate the use of the water herein granted at any and all times.

This permit does not extend the permittee the right of ingress and egress on public, private or corporate lands.

The total combined duty of water under Permits 67692, 68459, 68624, 69303, 70404, 70626, 71014, 71709-T, 71753, 71754, 71755, 72088, 72089 and 72090 shall not exceed 741.85 acre-feet annually.

The issuance of this permit does not waive the requirements that the permit holder obtain other permits from State, Federal and local agencies.

Monthly records shall be kept of the amount of water pumped from this well and other wells within the place of use of this permit. Records shall be submitted to the State Engineer on a quarterly basis within 15 days after the end of each calendar quarter. Separate reports shall be made for water pumped under permits and vested rights, and for water pumped under other authorization such as waivers. The monthly record shall identify water right permits and waivers from each well, and include the size, make, serial number, and meter location associated with a well.

The amount of water to be changed shall be limited to the amount which can be applied to beneficial use, and not to exceed 0.0483 cubic feet per second, and not to exceed 34.97 acre-feet annually.


