The applicant **Gregory P. Garling** hereby makes application for permission to change the **point of diversion and place of use of a portion** of water heretofore appropriated under **permit 21474 C. 6877**

1. The source of water is **UGW - well**
2. The amount of water to be changed **0.1434 cfs (18.36AF)**
3. The water to be used for **same as heretofore**
4. The water heretofore permitted for **Irrigation and domestic**
5. The water is to be diverted at the following point **SW¼ SW¼ Section 9 T.16N R.22E. M.D.B.&M. or at a point from which the SW corner of said Section 9 bears S. 57°30'W a distance of 1138 feet**
6. The existing permitted point of diversion is located within **SW¼ NW¼ Sec. 9 T.16N., R.22E., M.D.B.&M., or at a point from which the N¼ corner of said Sec. 9 bears N. 56°03' E. a distance of 3134.04 feet.**
7. Proposed place of use **N½ SE¼ SW¼ SW¼ Sec. 9 T.16.N, R.22E., M.D.B.&M. 4.59 ac**
8. Existing place of use **N½ SW¼ SW¼ SW¼ Sec. 9 T.16N, R.22E., M.D.B.&M. 4.59 ac**
9. Use will be from **1/1 to 12/ 31** of each year.
10. Use was permitted from **1/1 to 12/31** of each year.
11. Description of proposed works **10" -12" casing 100' -150' deep**
12. Estimated cost of works **\$20,000.00**
13. Estimated time required to construct works **5 years**
14. Estimated time required to complete the application of water to beneficial use **5 years**

APPROVAL OF STATE ENGINEER

This is to certify that I have examined the foregoing application, and do hereby grant the same, subject to the following limitations and conditions:

This permit to change the point of diversion and place of use of a portion of the waters of an underground source as heretofore granted under Permit 21474, Certificate 6877, is issued subject to the terms and conditions imposed in said Permit 21474, Certificate 6877, and with the understanding that no other rights on the source will be affected by the change proposed herein. The well shall be equipped with a 2-inch opening and a totalizing meter must be installed and maintained in the discharge pipeline near the point of diversion and accurate measurements must be kept of water placed to beneficial use. The totalizing meter must be installed before any use of the water begins or before the proof of completion of work is filed. If the well is flowing, a valve must be installed and maintained to prevent waste. This source is located within an area designated by the State Engineer pursuant to NRS 534.030. The State retains the right to regulate the use of the water herein granted at any and all times.

This permit does not extend the permittee the right of ingress and egress on public, private or corporate lands.

The total combined duty of water under Permits 71808 and 71809 shall not exceed 19.28 acre-feet annually.

The issuance of this permit does not waive the requirements that the permit holder obtain other permits from State, Federal and local agencies.

This Permit and Permit 71809 are limited to the irrigation of 4.82 acres within the described place of use.

The amount of water to be changed shall be limited to the amount which can be applied to beneficial use, and not to exceed 0.1434 cubic feet per second, but not to exceed 18.36 acre-feet annually, and not to exceed an annual duty of 4.0 acre-feet per acre of land irrigated from any and/or all sources.

Work must be prosecuted with reasonable diligence and be completed on or before:

March 3, 2009

Proof of completion of work shall be filed on or before:

April 3, 2009

Water must be placed to beneficial use on or before:

March 3, 2011

Proof of the application of water to beneficial use shall be filed on or before:

April 3, 2011


