Alpine Land and Reservoir Co., No. D-183 BRT**; both in the Federal District Court of Nevada and a **portion of permit #47804 & 48463**

This is to certify that I have examined the foregoing application, and do hereby grant the same, subject to the following limitations and conditions:

This permit, to change the place of use of a portion of the waters of the Newlands Reclamation Project rights in the Truckee and Carson River final decrees and as heretofore granted under Permit 48463, Certificate 16277, and a portion of Permit 47804 which changed the place of use of a portion of the Newlands Reclamation Project rights in the Truckee and Carson River final decrees, is issued subject to the terms and conditions imposed in said decrees and with the understanding that no other rights on the source will be affected by the change proposed herein.

This permit does not extend the permittee the right of ingress and egress on public, private or corporate lands.

The issuance of this permit does not waive the requirements that the permit holder obtain other permits from State, Federal and local agencies.

This permit is issued under the provisions of NRS 533.040 Paragraph 4 and is limited to the irrigation of 26.60 acres within the proposed place of use.


The amount of water to be changed shall be limited to the amount which can be applied to beneficial use, and not to exceed 93.10 acre-feet as decreed.
