The applicant Nevada Coin Mart Inc. make application for permission to change the Place of Use of water heretofore appropriated under Permit 62595

1. The source of water is **Underground**
2. The amount of water to be changed **0.0825 c.f.s., 13.776 acre-feet annually**

4. The water herctoforc permitted for **Quasi-municipal**
5. The water is to be diverted at the following point **NE¼ SW¼ Section 28, T.19S., R.57E., MDM, or at a point from which the W¼ corner of said Section 28 bears North 75° 16' 01" West, 2214 feet**

7. Proposed place of use within **S½ NE¼, SE¼ NW¼, NE¼ SW¼, and NW¼ SE¼ Section 28, T.19S., R.57E., MDM**
8. Existing place of use portion of **SW¼ NE¼ Section 28, T.19S., R.57E., MDM, also known as APN 470-080-016. This APN is currently known as 128-28-602-001**
9. Use will be from **January 1 to December 31** of each year.
10. Use was permitted from **January 1 to December 31** of each year.
11. Description of proposed works **well, pump and motor and distribution system**
12. Estimated cost of works **Existing**
13. Estimated time required to construct works **well is existing**
14. Estimated time required to complete the application of water to beneficial use. **5 years**
15. Remarks: **The place of use is being amended to coincide with the Mt. Charleston Water Company place of use. The water under this application is for development by Stan and Linda Zurawski and will be subject to the June 1999 Stipulated Agreement and Order Dismissing Case Without Prejudice. APPROVAL OF STATE ENGINEER

This is to certify that I have examined the foregoing application, and do hereby grant the same, subject to the following limitations and conditions:

This permit to change the place of use of the waters of an underground source as heretofore granted under Permit 62595 is issued subject to the terms and conditions imposed in said Permit 62595 and with the understanding that no other rights on the source will be affected by the change proposed herein. The well shall be equipped with a 2-inch opening and a totalizing meter must be installed and maintained in the discharge pipeline near the point of diversion and accurate measurements must be kept of water placed to beneficial use. The totalizing meter must be installed before any use of the water begins or before the proof of completion of work is filed. If the well is flowing, a valve must be installed and maintained to prevent waste. This source is located within an area designated by the State Engineer pursuant to NRS 534.030. The State retains the right to regulate the use of the water herein granted at any and all times.

This permit does not extend the permittee the right of ingress and egress on public, private or corporate lands.

The issuance of this permit does not waive the requirements that the permit holder obtain other permits from State, Federal and local agencies.

The permittee shall at the point of diversion of this permit, measure the depth to groundwater and the amount of water pumped for the purpose of this permit and Permit 72077 on a monthly basis and the records of such measurements shall be submitted on a quarterly basis within thirty (30) days after the end of each calendar quarter.

The State Engineer in response to the above water level measurements and amount of water pumped, may require that the permittee either drill a monitoring well at a location to be selected by the State Engineer, or enter into an agreement with another well user in the vicinity of the point of diversion under their permit at a location approved by the State Engineer, to verify the accuracy of the depth to groundwater data obtained and submitted to the State Engineer.

The amount of water to be appropriated shall be limited to the amount which can be applied to beneficial use, and not to exceed 0.0825 cubic feet per second, and not to exceed 13.776 acre-feet annually.
