The applicant **Washoe County, a Political Subdivision of the State of Nevada** hereby makes application for permission to change the **Point of Diversion and Place of Use** of water heretofore appropriated under **Permit 57952**

\*\*\*\*\*

1. The source of water is **underground**
2. The amount of water to be changed **0.0579 cfs, 28.840 acre-feet**
3. The water to be used for **municipal**
4. The water heretofore permitted for **municipal**
5. The water is to be diverted at the following point **Lot 1, Section 7, T.20N., R.21E., M.D.B.&M., or at a point from which the NE corner of Section 12, T20N., R.20E., bears S 44° 19' 35" W, a distance of 74.18 feet. This well is known as Spring Creek Well #6.**
6. The existing permitted point of diversion is located within **the SW¼ SW¼, Section 35, T.21N., R20E., MDB&M or at a point from which the NW corner of Section 2 T.20N., R20E., MDB&M bears S 37° 55' 01" W, a distance of 1575.31 feet.**
7. Proposed place of use **See amended Exhibit "A"**
8. Existing place of use **See attached Exhibit "B"**
9. Use will be from **January 1 to December 31** of each year.
10. Use was permitted from **January 1 to December 31** of each year.
11. Description of proposed works **Well, pump, treatment, storage and distribution facilities.**
12. Estimated cost of works **\$650,000.00**
13. Estimated time required to construct works **Completed. Spring Creek Well 6 has been drilled to a depth of 800 feet with a 20" nominal blank casing to 99 feet, a 12" nominal blank casing to 459 feet and a 12" nominal wire wrap screen 80 slot (0.080) from 459 feet to 797 feet. This well is equipped with a 10" sensus meter, serial number 46867, and a 10 HHA Peerless pump, serial number 578048-A.**
14. Estimated time required to complete the application of water to beneficial use **10 years**

APPROVAL OF STATE ENGINEER

This is to certify that I have examined the foregoing application, and do hereby grant the same, subject to the following limitations and conditions:

This permit to change the point of diversion and place of use of the waters of an underground source as heretofore granted under Permit 57952 is issued subject to the terms and conditions imposed in said Permit 57952 and with the understanding that no other rights on the source will be affected by the change proposed herein. The well shall be equipped with a 2-inch opening and a totalizing meter must be installed and maintained in the discharge pipeline near the point of diversion and accurate measurements must be kept of water placed to beneficial use. The totalizing meter must be installed before any use of the water begins or before the proof of completion of work is filed. If the well is flowing, a valve must be installed and maintained to prevent waste. This source is located within an area designated by the State Engineer pursuant to NRS 534.030. The State retains the right to regulate the use of the water herein granted at any and all times.

This permit does not extend the permittee the right of ingress and egress on public, private or corporate lands.

The total combined duty of water under Permits 51476, 51477, 57941, 57942, 57943, 57944, 57945, 57946, 57947, 57948, 57949, 57950, 57951, 57953, 57956, 64228, 64291, 72271, and 72272 shall not exceed 715.31 acre-feet annually.

The total combined duty of water under Permits 57946 and 72272 shall not exceed 28.84 acre-feet annually.

The issuance of this permit does not waive the requirements that the permit holder obtain other permits from State, Federal and local agencies.

Monthly records shall be kept of the amount of water pumped from this well and the records submitted to the State Engineer on a quarterly basis within 15 days after the end of each calendar quarter.

(PERMIT TERMS CONTINUED)

The amount of water to be changed shall be limited to the amount which can be applied to beneficial use, and not to exceed 0.0579 cubic feet per second, **but not to exceed 28.84 acre-feet annually.**

Work must be prosecuted with reasonable diligence and be completed on or before:
