The applicant **Brady Mining & Milling** hereby make application for permission to appropriate the public waters of the State of Nevada, as hereinafter stated.

This application is to provide additional water from the well under Permit 60079 and is to be commingled with the water in the application being filed concurrently, for water from the well under Permit 60078, for an additional total combined duty of 30 AFA. The water is to be utilized to expand the mining and milling operation previously described and on record at the Division of Water Resources in files 60078 and 60079. The total combined duty of the water under these two applications, and water under Permit 60078, Certificate 15443 and Permit 60079, Certificate 15444 is not to exceed 38.4 AFA.
