The applicant **Albert and Georgia Harrison** hereby make application for permission to change the **point of diversion and place of use of a portion** of water heretofore appropriated under **Permit 71074**

\*\*\*\*\*

1. The source of water is **underground**
2. The amount of water to be changed **1.385 CFS**
3. The water to be used for **irrigation & domestic**
4. The water heretofore permitted for **irrigation & domestic**
5. The water is to be diverted at the following point **within the SW $\frac{1}{4}$  NW $\frac{1}{4}$  of Section 13, T.38N., R.36E., M.D.B.&M., or at a point from which the W $\frac{1}{4}$  corner of said Section 13 bears S 45° W, a distance of 300.00 feet.**
6. The existing permitted point of diversion is located within **the NW $\frac{1}{4}$  SW $\frac{1}{4}$  of Section 25, T.39N., R.36E., M.D.B.&M. or at a point from which the W $\frac{1}{4}$  corner of said Section 25 bears N 86° 44' W, a distance of 73.0 feet.**
7. Proposed place of use **W $\frac{1}{2}$  of Section 13, T.38N., R.36E., M.D.B.&M. 240.18 acres**
8. Existing place of use **Section 25, T.39N., R.36E., M.D.B.&M. 480.36 acres, 240.18 acres are to be removed from the E $\frac{1}{2}$  of said Section 25.**
9. Use will be from **January 1<sup>st</sup> to December 31<sup>st</sup>** of each year.
10. Use was permitted from **January 1<sup>st</sup> to December 31<sup>st</sup>** of each year.
11. Description of proposed works **drilled well, buried pipeline and circular sprinkler.**
12. Estimated cost of works **\$100,000±**
13. Estimated time required to construct works **2 months**
14. Estimated time required to complete the application of water to beneficial use **3 years**
15. Remarks: **See map supporting Application 72190. Applicant has filed Application 72190 which changes the Point of Diversion & Place of Use of Permit 71073. Applicant wishes to drill the new well requested by Application 72190 so that water is available for this irrigation season.**

APPROVAL OF STATE ENGINEER

This is to certify that I have examined the foregoing application, and do hereby grant the same, subject to the following limitations and conditions:

This temporary permit to change the point of diversion and place of use of a portion of the waters of an underground source as heretofore granted under Permit 71073 is issued subject to the terms and conditions imposed in said Permit 71073 and with the understanding that no other rights on the source will be affected by the change proposed herein. The well shall be equipped with a 2-inch opening and a totalizing meter must be installed and maintained in the discharge pipeline near the point of diversion and accurate measurements must be kept of water placed to beneficial use. The totalizing meter must be installed before any use of the water begins or before the proof of completion of work is filed. If the well is flowing, a valve must be installed and maintained to prevent waste. This source is located within an area designated by the State Engineer pursuant to NRS 534.030. The State retains the right to regulate the use of the water herein granted at any and all times.

This temporary permit does not extend the permittee the right of ingress and egress on public, private or corporate lands.

The issuance of this temporary permit does not waive the requirements that the permit holder obtain other permits from State, Federal and local agencies.

The total combined duty of water under Permits 72357-T and 72563-T shall not exceed 960.72 acre-feet annually.

This temporary permit is issued pursuant to the provisions of NRS 533.345 Section 2 and will expire on June 13, 2006 at which time all rights herein granted shall revert to the right being changed by this temporary permit.

The amount of water to be appropriated shall be limited to the amount which can be applied to beneficial use, and not to exceed 1.385 cubic feet per second, not to exceed 960.72 acre-feet annually, and not to exceed a yearly duty of 4.0 acre-feet per acre of land irrigated from any and/or all sources.

Work must be prosecuted with reasonable diligence and be completed on or before:


