1. The source of the proposed appropriation is **Underground (Carbonate System) Well I**

8. Description of proposed works **Carbonate well drilled and cased to the proven depths of the carbonate aquifer equipped with pump and motor.**
9. Estimated cost of works is **\$10,000,000.00+**
10. Estimated time required to construct works **Five (5) years**
11. Estimated time required to complete the application of water to beneficial use **Ten (10) years**

DENIAL OF STATE ENGINEER


This application is hereby denied on the grounds that its approval would conflict with existing rights and would threaten to prove detrimental to the public interest.

No. 6: Place of Use

Township 12 South, Range 63 East, (Lincoln County, Nevada):

All of Sections 2, 3, 4, 5, 8, 9, 10, 11, 14, 15, 16, 17, 20, 21, 22, 23, 25, 26, 27, 28, 33, 34, 35, and 36; Sections 1, 13, and 24, the West Half (W1/2); Section 12, the West Half (W1/2) of the West Half (W1/2); Sections 6, 7, 18, 19, 29, 30, and 32, all except those portions lying West of the Centerline of U. S. Highway 93.

Township 12 South, Range 64 East, (Lincoln County, Nevada):

The West Half (W1/2) of the Southwest Quarter (SW1/4) of Section 31.

Township 13 South, Range 63 East, (Clark County, Nevada):

All of Sections 1, 2, 3, 4, 9, 10, 11, 12, 13, 14, 15, 16, 24; Sections 20, 21, 22, 23 and 25, all except those portions lying South of the Centerline of State Highway 168; Sections 5, 8, 17, and 20, all except those portions lying West of the Centerline of U. S. Highway 93.
