The applicant **Robert W. and Nanette Marshall** hereby make application for permission to change the **Point of diversion, place of use and manner of use** of water heretofore appropriated under **Permit 64073**

1. The source of water is **Warm Springs Valley Creek and Tributaries**
2. The amount of water to be changed **4.612 cfs, not to exceed 638.4 acre feet annually**
3. The water to be used for **Irrigation and domestic**
4. The water heretofore permitted for **Municipal and domestic**
5. The water is to be diverted at the following point (1) **NW $\frac{1}{4}$ of NE $\frac{1}{4}$ section 30, T24N R20E, MDM or at a point from which the E $\frac{1}{4}$ corner of Section 4, T23N, R20E, MDM BEARS S44 degrees 50' 58" E, a distance of 17,860.69 feet; POD #2) SE $\frac{1}{4}$ OF NE $\frac{1}{4}$ Section 30, T24N R20E, MDM or at a point from which the E $\frac{1}{4}$ corner of section 4, T23N R20E, MDM BEARS S44 degrees 18' E, a distance of 15,635.0 feet.**
6. The existing permitted point of diversion is located within **POD #1) NW $\frac{1}{4}$ OF NE $\frac{1}{4}$ section 30, T24N, R20E MDM, or at a point from which the E $\frac{1}{4}$ corner of sec 4, T23N, R20E, MDM BEARS S 44 degrees 24' 43' E, a distance of 17,985.74 feet; POD #2) SE $\frac{1}{4}$ of SE $\frac{1}{4}$ of section 19, T24N, R20E MDM or at a point from which the E $\frac{1}{4}$ corner of section 4, T23N, R20E, MDM bears S 40 degrees 22' 36" E, a distance of 17,462.12 feet.**
