The applicant **JackRabbit Properties, LLC** hereby makes application for permission to appropriate the public waters of the State of Nevada, as hereinafter stated. (If applicant is a corporation, give date and place of incorporation; if copartnership or association give names of members). **December 4, 2001 - Nevada**

1. The source of the proposed appropriation is **underground source**
2. The amount of water applied for is **2.0 cfs – 300 acre feet per annum** second-feet

3. The water to be used for **municipal and domestic purposes**
4. If use is for:
 - (a) Irrigation, state number of acres to be irrigated
 - (b) Stockwater, state number and kinds of animals to be watered

 - (1) Horsepower developed
 - (2) Point of return of water to stream
5. The water is to be diverted from its source at the following point **within the NW ¼ of the SE ¼ of Section 17 T29N, R19E, MDM, or at a point from which the southeast corner of said Section 17 bears South 44° 42' East a distance of 2751 feet. Proposed POD lies within Basin No. 19 – Dry Valley.**
6. Place of Use **within Designated Groundwater Basins No.'s 100, 92A, 92B and 93 all within Washoe County, Nevada. See attached Exhibit "A".**
7. Use will begin about **January 1** and end about **December 31** of each year.
8. Description of proposed works **Drilled and cased well equipped with motor, pump and pipeline to place of use.**
9. Estimated cost of works **\$300,000**
10. Estimated time required to construct works **5 years**
11. Estimated time required to complete the application of water to beneficial use **10 years**
