

Refer to supporting map filed with Application. (Basin #79).**
6. Place of Use within **Basins 76, 83, 84, 85 & 87 as determined by the Nevada State Engineer's records.**
7. Use will begin about **January 1st** and end about **December 31st** of each year.
8. Description of proposed works **Drilled and cased well with pump & motor.**
9. Estimated cost of works **One Million Dollars +**
10. Estimated time required to construct works **Five (5) Years**
11. Estimated time required to complete the application of water to beneficial use **Ten (10) Years**
