The applicant **Logan Creek General Improvement District** hereby make(s) application for permission to change the **Point of diversion Place of use Manner of use of a portion** of water heretofore appropriated under **Permit 22786**

1. The source of water is **Lake Tahoe via Logan Shoals Creek No. 2**
2. The amount of water to be changed **1.832 acre-feet**
3. The water to be used for **Municipal**
4. The water heretofore permitted for **Quasi-Municipal and Domestic**
5. The water is to be diverted at the following point **within Lot 1 extended (SW $\frac{1}{4}$ SW $\frac{1}{4}$) of Section 16, Township 16 North, Range 18 East, M.D.M. at a point from which the W $\frac{1}{4}$ corner of said Section 16 bears North 22° 50' 57" West a distance of 2,487.93 feet.**
6. The existing permitted point of diversion is located within **NE $\frac{1}{4}$ NE $\frac{1}{4}$, Section 22, Township 14 North, Range 18 East, M.D.M., or at a point from which the NE corner of said Section 22 bears North 2° 00' East a distance of 1,160 feet (Logan Shoals Creek #2).**
7. Proposed place of use **See Attachment "A"**
8. Existing place of use **The SE $\frac{1}{4}$ NE $\frac{1}{4}$ in Section 22, Township 14 North, Range 18 East.**
9. Use will be from **January 1 to December 31** of each year.
10. Use was permitted from **January 1 to December 31** of each year.
11. Description of proposed works **Existing lake intake facility, submerged pipelines, pumps and meters.**
12. Estimated cost of works **Existing**
13. Estimated time required to construct works **Existing**
14. Estimated time required to complete the application of water to beneficial use **Ten (10) years**

15. Remarks: Appropriation of the water will support a large addition to an educational facility located within the Incline Village General Improvement District. See Maps on file with the Division of Water Resources in support of Permits 22786 and 23486 to identify existing Place of Use and Point of Division. Proposed Place of Use and Point of Diversion are depicted on Map supporting Application 64298.

APPROVAL OF STATE ENGINEER

This is to certify that I have examined the foregoing application, and do hereby grant the same, subject to the following limitations and conditions:

This permit to change the point of diversion, place of use and manner of use of a portion of the waters of Lake Tahoe heretofore granted under Permit 22786 is issued subject to the terms and conditions imposed in said Permit 22786 and with the understanding that no other rights at the source shall be affected by the change proposed herein. A totalizing meter must be installed in the discharge pipeline near the point of diversion and accurate measurements must be kept of water placed to a beneficial use. This permit is subject to the final allocation of the State of Nevada under the California-Nevada-Interstate Compact Commission or any subsequent allocation approved by both states. The State retains the right to regulate the use of the water herein granted at any and all times.

This permit does not extend the permittee the right of ingress and egress on public, private or corporate lands.

The issuance of this permit does not waive the requirements that the permit holder obtain other permits from State, Federal and local agencies.

The amount of water to be changed shall be limited to the amount which can be applied to beneficial use, and not to exceed 0.0105 cubic feet per second, **but not to exceed 1.832 acre-feet annually.**
