This is to certify that I have examined the foregoing application, and do hereby grant the same, subject to the following limitations and conditions:

This permit to change the place and manner of use of a portion of the waters of Knott Creek and Tributaries as heretofore granted under Permit 49043 is issued subject to the terms and conditions imposed in said Permit 49043 and with the understanding that no other rights on the source will be affected by the change proposed herein. A measuring device must be installed and measurements of water use kept

This permit does not extend the permittee the right of ingress and egress on public, private or corporate lands.

The issuance of this permit does not waive the requirements that the permit holder obtain other permits from State, Federal and local agencies.

The point of diversion and place of use is as described under items 5 and 7 respectively on the submitted application to support this permit.

The amount of water to be appropriated shall be limited to the amount which can be applied to beneficial use, and not to exceed 0.0167 cubic feet per second, but not to exceed 5.97 acre-feet annually.

Work must be prosecuted with reasonable diligence and proof of completion of work shall be filed on or before:

August 8, 2008

Water must be placed to beneficial use and proof of the application of water to beneficial use shall be filed on or before:

August 8, 2008

The applicant **United States of America, Department of Interior, Bureau of Land Management** hereby makes application for permission to change the **Place of use Manner of use of a portion** of water heretofore appropriated under **49043**

1. The source of water is **Knott Creek and Tributaries**
2. The amount of water to be changed **0.0167 cfs, not to exceed 1.944 mga**
3. The water to be used for **Wildlife Purposes**
4. The water heretofore permitted for **Quasi-municipal**
5. The water is to be diverted at the following point **within the SE¼ NW¼ of Section 17, T.43N., R.28E., M.D.B.&M, or at a point from which the N¼ corner of said Section 17 bears N 01°01' E 2585'** (See map on file under permit 49043)
6. The existing permitted point of diversion is located within
7. Proposed place of use **Portions of Section 8, T.43N., R. 28E., MDB&M** (See map on file under application 70830)
8. Existing place of use **within the E½ NW¼ of Section 17, T.43N., R.28E., MDB&M**
9. Use will be from **January 1 to December 31** of each year.
10. Use was permitted from **May 1 to October 31** of each year.
11. Description of proposed works. **No "works" will be required Use will be "in situ"**
12. Estimated cost of works **No "works" are required. The Bureau of Land Management expended \$1,890,000.00 to acquire several parcels and associated water rights for recreation, access and wildlife purposes.**
13. Estimated time required to construct works **The purchasing action is complete, future time requirements will depend upon the water right permit requirements**
14. Estimated time required to complete the application of water to beneficial use **See item 13**
15. Remarks: **Wildlife use of the water will occur along the length of the natural channel and then within the pool of Knut Creek Reservoir. The original permits which are being abrogated by this action were established to support the Pine Forest Estates subdivision. The Bureau of Land Management purchased the remaining lots within the subdivision and is hereby changing the unused portions of permits 49042, 49043, and 49044.**
