The applicant **Rodney and Diana Roy** hereby makes application for permission to change the **Point of Diversion and Place of Use of a portion** of water heretofore appropriated under **Claim or Right No. 337/338 of the Truckee River Decree, said Decree entered by the District Court of the United States for Nevada in that certain action entitled, "The United States of America, Plaintiff vs. Orr Water Ditch Company, et al., Defendants", in Equity Docket A-3.**

1. The source of water is **Truckee River**
2. The amount of water to be changed **0.56 afa and a pro-rata share of the diversion rate**
3. The water to be used for **As Decreed**
4. The water heretofore permitted for **As Decreed**
5. The water is to be diverted at the following point **NE¼ of the NW¼ of Section 19, T19N, R19E, MDB&M, or at a point from which the Northwest corner of Section 20, T19N, R19E, MDB&M bears South 88° 05' East a distance of 2,620.0' Feet. Lake Ditch per Orr Ditch Decree.**
6. The existing point of diversion is located within **NE¼ of the SW¼ of Section 17, T19N, R19E, MDB&M, or at a point from which the Northwest corner of Section 20, T19N, R19E, MDB&M bears South 44° 40' West a distance of 3,211.0' Feet. Orr Extension per Orr Ditch Decree.**
7. Proposed place of use **In the SE¼ of the SW¼ of Section 6, T18N, R20E, MDB&M. Also referred as APN 043-140-07, shown on TR-013 on file in the office of the Division of Water Resources, State of Nevada. See attached APN map.**
8. Existing place of use **0.14 acres in the NW¼ of the NW¼ of Section 35, T20N, R20E, MDB&M. APN 030-134-04 is shown on TR-049-4 on file in the office of the Division of Water Resources, State of Nevada.**
9. Use will be from **As Decreed** to **As Decreed** of each year.
10. Use was permitted from **As Decreed** to **As Decreed** of each year.
11. Description of proposed works **Irrigation purposes.**

APPROVAL OF STATE ENGINEER

This is to certify that I have examined the foregoing application, and do hereby grant the same, subject to the following limitations and conditions:

This permit to change the point of diversion and place of use of a portion of the waters of the Truckee River as heretofore granted under Claims 337/338, Truckee River Final Decree is issued subject to the terms and conditions imposed in said decree and with the understanding that no other rights on the source will be affected by the change proposed herein. A suitable measuring device must be installed and accurate measurements of water placed to beneficial use must be kept.

This permit does not extend the permittee the right of ingress and egress on public, private or corporate lands.

The issuance of this permit does not waive the requirements that the permit holder obtain other permits from State, Federal and local agencies.

This permit is limited to the irrigation of 0.14 acres within the described place of use and not to exceed an annual duty of 4.0 acre-feet per acre of land irrigated from any and/or all sources. The period of use is as decreed.

The amount of water to be changed shall be limited to the amount which can be applied to beneficial use, and not to exceed 0.002 cubic feet per second, **but not to exceed 0.56 acre-feet as decreed.**

Work must be prosecuted with reasonable diligence and be completed on or before:

August 14, 2007

Proof of completion of work shall be filed on or before:

September 14, 2007

Water must be placed to beneficial use on or before:

August 14, 2011

Proof of the application of water to beneficial use shall be filed on or before:

September 14, 2011

Map in support of proof of beneficial use shall be filed on or before:


