The applicant **Aqua Trac, LLC** hereby make application for permission to appropriate the public waters of the State of Nevada, as hereinafter stated. **Aqua Trac, LLC (Limited Liability Company as of 3/11/2005, in Reno, Nevada)**

1. The source of the proposed appropriation is **Underground**
2. The amount of water applied for is **4.0 CFS** second-feet
  - (a) If stored in reservoir give number of acre-feet
3. The water to be used for **Quasi-Municipal**
4. If use is for:
  - (a) Irrigation, state number of acres to be irrigated
  - (b) Stockwater, state number and kinds of animals to be watered
  - (c) Other use (describe fully under No. 12. "Remarks") **See Remarks**
  - (d) Power:
    - (1) Horsepower developed
    - (2) Point of return of water to stream
5. The water is to be diverted from its source at the following point **within the SW<sup>1</sup>/<sub>4</sub> SE<sup>1</sup>/<sub>4</sub> Section 34, T25N, R25E, MDM, or at a point from which the N<sup>1</sup>/<sub>4</sub> corner of Section 17, T25N, R27E, MDM, bears N 69°38'46" E, a distance of 56,200.0 feet. Refer to supporting map filed with Application. (Basin #78).**
6. Place of Use **within Basins 76, 83, 84, 85 & 87 as determined by the Nevada State Engineer's records.**
7. Use will begin about **January 1st** and end about **December 31st** of each year.
8. Description of proposed works **Drilled and cased well with pump & motor.**
9. Estimated cost of works **One Million Dollars +**
10. Estimated time required to construct works **Five (5) Years**
11. Estimated time required to complete the application of water to beneficial use **Ten (10) Years**

**DENIAL OF STATE ENGINEER**

This application is hereby denied on the grounds that:

1. There is insufficient water in the proposed source to support the applications.
2. No contracts with those who would place the water to beneficial use were demonstrated nor was any agency relationship with a municipality or other entity was demonstrated; therefore, the Applicant did not satisfy the requirements for demonstrating a need for the water under NRS §533.370(6).
3. No demonstration was made of the actual project to be constructed; therefore, no specific beneficial use of the water was identified.
4. No evidence was provided as to the amount of water reasonably required for any specific project.
5. To grant the applications under these conditions would thereby threaten to prove detrimental to the public interest.
