APPROVAL OF STATE ENGINEER

This is to certify that I have examined the foregoing application, and do hereby grant the same, subject to the following limitations and conditions:

This permit to change the point of diversion, place and manner of use of the waters of an underground source as heretofore granted under Permit 64386 is issued subject to the terms and conditions imposed in said Permit 64386 and with the understanding that no other rights on the source will be affected by the change proposed herein. The well shall be equipped with a 2-inch opening and a totalizing meter must be installed and maintained in the discharge pipeline near the point of diversion and accurate measurements must be kept of water placed to beneficial use. The totalizing meter must be installed before any use of the water begins or before the proof of completion of work is filed. If the well is flowing, a valve must be installed and maintained to prevent waste. This source is located within an area designated by the State Engineer pursuant to NRS 534.030. The State retains the right to regulate the use of the water herein granted at any and all times.

Monthly records shall be kept of the amount of water pumped from this well and the records submitted to the State Engineer on an annual basis within 30 days after the end of each calendar year.

This permit does not extend the permittee the right of ingress and egress on public, private or corporate lands.

The total combined duty of water under Permits 73580, and 73821 shall not exceed 4.48 acre-feet annually for the service of four parcels within the described place of use, at a duty of 1.12 acre-feet annually per parcel.

The issuance of this permit does not waive the requirements that the permit holder obtain other permits from State, Federal and local agencies.

The point of diversion and place of use is as described under items 5 and 7 respectively on the submitted application to support this permit.

The amount of water to be changed shall be limited to the amount which can be applied to beneficial use, and not to exceed 0.0078 cubic feet per second, but not to exceed 4.0 acre-feet annually.

Work must be prosecuted with reasonable diligence and proof of completion of work shall be filed on or before:

June 26, 2008

Water must be placed to beneficial use and proof of the application of water to beneficial use shall be filed on or before:

June 26, 2011

Map in support of proof of beneficial use shall be filed on or before:

The applicant **Elko Summit Limited** hereby makes application for permission to change the **Point of Diversion Manner of Use and Place of Use for 4.00 Acre Feet Annually** of water heretofore appropriated under **All of Permit #64386**.

\*\*\*\*\*

1. The source of water is **Underground**
2. The amount of water to be changed **4.00 A.F.A., being all 4.00 A.F.A. of Permit #64386**
3. The water to be used for **Quasi-Municipal (Residential Land Development)**
4. The water heretofore permitted for **Irrigation & Domestic**
5. The water is to be diverted at the following point **NW $\frac{1}{4}$  SW $\frac{1}{4}$  of Section 25, T.34N., R.55E., M.D.B.&M., at a point from which the SE corner of said Section 25 bears S 74° 04' 36" E, a distance of 5,050.34' feet.**
6. The existing permitted point of diversion is located within **NW $\frac{1}{4}$  NE $\frac{1}{4}$  of Section 17, T.34N., R.55E., M.D.B.&M., at a point from which the N $\frac{1}{4}$  corner of said Section 17 bears N 14° 51' 07" W a distance of 1,010.25' feet.**
7. Proposed place of use **4.00 A.F.A. to the Remainder Parcel of the BLA file #528808, filed in the Elko County Recorders office on Dec. 20, 2004, being a portion of Section 36, T.34N., R.55E., M.D.B.&M.,**
8. Existing place of use a portion of **NW $\frac{1}{4}$  NE $\frac{1}{4}$  of Section 17, T.34N., R.55E., M.D.B.&M.,**
9. Use will be from **January 1 to December 31** of each year.
10. Use was permitted from **January 1 to December 31** of each year.
11. Description of proposed works **Well Pump & Motor, and pipeline to place of use.**
12. Estimated cost of works **\$30,000.00**
13. Estimated time required to construct works **1 year**
14. Estimated time required to complete the application of water to beneficial use **4 years**

15. Remarks: **The remainder, is in the process of being developed and the 4.00 Acre Feet Annually, will be applied to 3.57 Residential Building Lots, allowing 1.12 Acre Feet per Unit. Two reasons caused this water to not be previously transferred to Section 36. First, Elko County was in a terrible economic slump from 1997 until the first of 2005, due mainly to the price of Gold. Note #64386 & #55407 had been purchased for the purpose of developing the land in Sections 25 and 36, and putting the water to beneficial use. Second, Chuck Armuth, Jr. the water right surveyor had been progressively sick this last year with heart failure. During his last month he was bed ridden, and died the last of August, 2005. We feel that he would have applied for this change during his last year if he hadn't been so sick**
