This is to certify that I have examined the foregoing application, and do hereby grant the same, subject to the following limitations and conditions:

This permit to change the point of diversion, manner of use and place of use of a portion of the waters of an underground source as heretofore granted under Permit 67198 is issued subject to the terms and conditions imposed in said Permit 67198 and with the understanding that no other rights on the source will be affected by the change proposed herein.

Monthly records shall be kept of the amount of water pumped from this well and the records submitted to the State Engineer on a quarterly basis within 15 days after the end of each calendar quarter.

This permit does not extend the permittee the right of ingress and egress on public, private or corporate lands.

The issuance of this permit does not waive the requirements that the permit holder obtain other permits from State, Federal and local agencies.

The point of diversion and place of use are as described on the submitted application to support this permit.

The amount of water to be appropriated shall be limited to the amount which can be applied to beneficial use, and not to exceed 0.1017 cubic feet per second, but not to exceed 73.61 acre-feet annually.

Work must be prosecuted with reasonable diligence and proof of completion of work shall be filed on or before:

February 26, 2009

Water must be placed to beneficial use and proof of the application of water to beneficial use shall be filed on or before:

February 26, 2013

The applicant **Washoe County, a political subdivision of the State of Nevada**, hereby make application for permission to change the **Point of diversion Place of use Manner of use of a portion** of water heretofore appropriated under **Permit 67198**

1. The source of water is **Underground water well #1**
2. The amount of water to be changed **0.102 cfs (73.61 AF)**
3. The water to be used for **Municipal and Domestic**
4. The water heretofore permitted for **Commercial and Domestic**
5. The water is to be diverted at the following point **SW¹/₄ NE¹/₄, Section 8, T.20N., R.24E., MDB&M, or at a point from which the W¹/₄ corner of said Section 8 bears S. 66° 05' 40" W., a distance of 2953.3 feet.**
6. The existing permitted point of diversion is located within **NW¹/₄ NE¹/₄, Section 13, T.20N., R.23E., MDB&M, or at a point from which the N¹/₄ corner of said section 13 bears N. 51° 34' W., a distance of 833 feet**
7. Proposed place of use **S¹/₂ NW¹/₄, portions of NW¹/₄ NE¹/₄, SW¹/₄ NE¹/₄, NW¹/₄ SW¹/₄, NE¹/₄ SW¹/₄, SW¹/₄ SW¹/₄ all in Section 8, T.20N., R.24E., MDB&M.**
8. Existing place of use **NW¹/₄ NE¹/₄, NE¹/₄ NE¹/₄, SW¹/₄ NE¹/₄, and a portion SE¹/₄ NE¹/₄ lying north of northerly right-of-way line of I-80; Section 13, T.20N., R.23E., MDB&M.**
9. Use will be from **.1/1 to 12/31** of each year.
10. Use was permitted from **1/1 to 12/31** of each year.
11. Description of proposed works **Deep well, pump, motor and distribution lines.**
12. Estimated cost of works **Complete**
13. Estimated time required to construct works **Complete**
