The applicant See Attachment "A" hereby makes application for permission to change the **Manner and Place of use of a portion** of water heretofore appropriated under **Claim 706 of the Truckee River Decree as entered by the District Court for Nevada in that certain action entitled, "The United States of America, plaintiff, vs. Orr Water Ditch Company, et al, defendants" in Equity Docket A-3**

1. The source of water is **Steamboat Creek & Tributaries**
2. The amount of water to be changed **3.091 cfs not to exceed 558.63 acre-feet annually**
3. The water to be used for **Instream Flow**
4. The water heretofore permitted for **As decreed**
5. The water is to be diverted at the following point **As decreed – Candler Ditch from the East bank, NW ¼ SE ¼, Section 33, T.18N., R.20E., M.D.B.&M.**
6. The existing permitted point of diversion is located within **Unchanged**
7. Proposed place of use **See Attachment "B"**
8. Existing place of use **See Attachment "C"**
9. Use will be from **January 1 to December 31** of each year.
10. Use was permitted from **As Decreed.**
11. Description of proposed works **Water will be diverted through existing stream channel and Truckee River**
12. Estimated cost of works **Dependent upon Permit Terms**
13. Estimated time required to construct works **Dependent upon Permit Terms**
14. Estimated time required to complete the application of water to beneficial use **Ten (10) Years**

15. Remarks: Water will be diverted within the existing Steamboat Creek Channel to provide in stream flows between the point of diversion and the Vista Gauge on the Truckee River. Upon passing the Vista Gauge, the water will be considered return flow and be available for downstream users. APPROVAL OF STATE ENGINEER

This is to certify that I have examined the foregoing application, and do hereby grant the same, subject to the following limitations and conditions:

This permit to change the place of use and manner of use of a portion of the waters of Steamboat Creek as heretofore granted under Claim 706, Truckee River Final Decree is issued subject to the terms and conditions imposed in said decree and with the understanding that no other rights on the source will be affected by the change proposed herein. A suitable measuring device must be installed and accurate measurements of water placed to beneficial use must be kept.

This permit does not extend the permittee the right of ingress and egress on public, private or corporate lands.

The issuance of this permit does not waive the requirements that the permit holder obtain other permits from State, Federal and local agencies.

Measuring devices shall be designed and a monitoring plan shall be submitted to and approved by the State Engineer prior to filing the proof of completion of work. Futhermore, no return flow credit water for subdivisions will be approved from this permit until data supporting the use has been approved by this office.

This permit is issued subject to the continuing jurisdiction and regulation by the Federal Water Master and the State Engineer.

By issuance of this permit, the supplemental storage rights described under Truckee River Claim Numbers 660 and 669 can no longer be used at the existing place of use.

The amount of water to be changed shall be limited to the amount which can be applied to beneficial use, and not to exceed 3.091 cubic feet per second, but not to exceed 558.63 acre-feet as decreed.

Work must be prosecuted with reasonable diligence and proof of completion of work shall be filed on or before:

December 18, 2008

Water must be placed to beneficial use and proof of the application of water to beneficial use shall be filed on or before:

December 18, 2011

Map in support of proof of beneficial use shall be filed on or before:
