The applicant **Desert Utilities, Inc.** hereby makes application for permission to change the **Point of Diversion, Place and Manner of Use of a portion** of water heretofore appropriated under **Permit 13958, Certificate 5436**

1. The source of water is **Underground**
2. The amount of water to be changed **0.10 c.f.s. (59.7 AFA)**
3. The water to be used for **Municipal**
4. The water heretofore permitted for **Irrigation**
5. The water is to be diverted at the following point **SE1/4NE1/4 Section 11, T.21 S., R. 54 E., M.D.M., or at a point from which the East ¼ corner of said Section 11 bears South 38° 49' East, a distance of 1,597 feet. (Gateway Well 2)**
6. The existing permitted point of diversion is located within **NE1/4NW1/4 Section 3, T. 20 S., R.53 E., MDM, or at a point from which the N1/4 corner of said Section 3 bears North 45° East., a distance of 100 feet.**
7. Proposed place of use **See Attached**
8. Existing place of use **31.45 acres in the SE1/4NE1/4 (34.28 acres less 2.83 acres stripped under Application 65735) and 22.89 acres (25.0 acres less 2.11 acres stripped under Application 65734) in Section 5, T.20 S., R. 53 E., M.D.M. This Application will remove 11.94 acres within the SE1/4NE1/4 Section 5, T. 20 S., R. 53 E., M.D.M. as shown on accompanying map.**
9. Use will be from **January 1 to December 31** of each year.
10. Use was permitted from **January 1 to December 31** of each year.
11. Description of proposed works **well, pump, motor, storage tank and water distribution system**
12. Estimated cost of works **In excess of \$1,000,000**
13. Estimated time required to construct works **2 years**
14. Estimated time required to complete the application of water to beneficial use **10 years**
