The applicant **Desert Utilities, Inc.** hereby makes application for permission to change the **Point of Diversion, Place and Manner of Use** of water heretofore appropriated under **Permit 62674**

1. The source of water is **Underground**
2. The amount of water to be changed **0.10 c.f.s. (6.5 A.F.A.)**
3. The water to be used for **Municipal**
4. The water heretofore permitted for **Irrigation and Domestic**
5. The water is to be diverted at the following point **NE1/4SW1/4 Section 11, T. 21 S., R. 54 E., M.D.M., or at a point from which the East 1/4 corner of said Section 11 bears N. 72° 43' E., a distance of 4,083 feet. (Gateway Well #4)**
6. The existing permitted point of diversion is located within **SE1/4NW1/4 Section 34, T.19 S., R.53 E., MDM, or at a point from which the Center 1/4 corner of said Section 34 bears South 36° 10' 26" East., a distance of 545.3 feet.**
7. Proposed place of use **See Attached**
8. Existing place of use **Within the SE1/4NW1/4 Section 34, T.19 S., R.53 E., M.D.M. in Nye County, Nevada, being lots 6, 7, 8, & 9 of Block 7, Rancho Del Sol Subdivision Unit 3, File No. 49565, Nye County Records. All acreage under Permit 62674 to be removed from irrigation under this Application. (Together with Application 74143, a total of 3.30 acres will be removed from this place of use.)**
9. Use will be from **January 1 to December 31** of each year.
10. Use was permitted from **January 1 to December 31** of each year.
11. Description of proposed works **well, pump, motor, storage tank and water distribution system**
12. Estimated cost of works **In excess of \$1,000,000**
13. Estimated time required to construct works **2 years**
14. Estimated time required to complete the application of water to beneficial use **10 years**
