The applicant **Desert Utilities, Inc.** hereby makes application for permission to change the **Point of Diversion, Place and Manner of Use** of water heretofore appropriated under **Permit 64641**

1. The source of water is **Underground**
2. The amount of water to be changed **0.0269 c.f.s. (17.6 A.F.A.)**
3. The water to be used for **Municipal**
4. The water heretofore permitted for **Irrigation**
5. The water is to be diverted at the following point **NE1/4SE1/4 Section 2, T. 21 S., R. 54 E., M.D.M., or at a point from which the Center ¼ corner of said Section 2 bears North 47° 45' West, a distance of 170 feet. (Gateway Well #3)**
6. The existing permitted point of diversion is located within **NE1/4NW1/4 Section 3 T.20 S., R.53 E., MDM, or at a point from which the N1/4 corner of said Section 3 bears North 45° East., a distance of 100 feet.**
7. Proposed place of use **See Attached**
8. Existing place of use **3.52 acres within the S1/2 NE1/4 Section 5, T.20 S., R.53 E., M.D.M. All 3.52 acres to be removed from irrigation under this Application.**
9. Use will be from **January 1 to December 31** of each year.

11. Description of proposed works **well, pump, motor, storage tank and water distribution system**
