APPROVAL OF STATE ENGINEER

This is to certify that I have examined the foregoing application, and do hereby grant the same, subject to the following limitations and conditions:

This temporary permit to change the point of diversion, place of use and manner of use of a portion of the waters of Galena Creek, as heretofore granted under Permit 25335, Certificate 8477, which changed the point of diversion and place of use of a portion of Claim No. 652 Truckee River Decree is issued subject to the terms and conditions imposed in said decree and with the understanding that no other rights on the source will be affected by the change proposed herein. A suitable measuring device must be installed and accurate measurements of water placed to beneficial use must be kept.

This temporary permit does not extend the permittee the right of ingress and egress on public, private or corporate lands.

The issuance of this temporary permit does not waive the requirements that the permit holder obtain other permits from State, Federal and local agencies.

Not more than 20% of the flow of Galena Creek to a maximum of 3.3034 cubic feet per second may be diverted from point of diversion #2 (north diversion point) under 65729, 65730, 74217T, 74218T, 74219T, and 74220T.

The issuance of this temporary permit fully abrogates 107.7263 acre-feet per season as described in the existing place of use of Permit 25335.

The issuance of this temporary permit is for the consumptive use portion only, being 2.5 acre-feet per acre of the base right consistent with State Engineer's Ruling #5359 dated June 3, 2004.

This temporary permit is subject to the continuing jurisdiction and regulation of the Federal Water Master.

This temporary permit is issued pursuant to the provisions of NRS 533.345 Section 2 and will expire on October 15, 2006, at which time all rights herein granted shall revert to the right being changed by this temporary permit.

The amount of water to be changed shall be limited to the amount which can be applied to beneficial use, and not to exceed 0.5997 cubic feet per second, but not to exceed 59.85 acre-feet as decreed.
