The applicant **Sunrise Ranch LLC** hereby make application for permission to change the **Point of Diversion and place of use** of water heretofore appropriated under **Permit # 66888**

6. The existing permitted point of diversion is located within **SW $\frac{1}{4}$  NW $\frac{1}{4}$ , Sec. 30, T. 14N, R. 26E MDB&M or at a point from which the NW corner of Sec. 18, T. 14N, R. 26E M.D.B.&M. bears No5° 12' 02" W, a distance of 13,097 feet**

Proposed place of use **79.74 acres located in portions of the NW $\frac{1}{4}$  of the NE $\frac{1}{4}$ , the NE $\frac{1}{4}$  of the NW $\frac{1}{4}$ , the SW $\frac{1}{4}$  of the NE $\frac{1}{4}$ , and the SE $\frac{1}{4}$  of the NW $\frac{1}{4}$  of Section 22, T. 14N., R. 26E M.D.B. & M.**
8. Existing place of use **W $\frac{1}{2}$  of Section 19 and the W $\frac{1}{2}$  of the NW $\frac{1}{4}$  of Section 30, T. 14N., R 26 E., MDB. & M.**

APPROVAL OF STATE ENGINEER

This is to certify that I have examined the foregoing application, and do hereby grant the same, subject to the following limitations and conditions:

This permit to change the point of diversion and place of use of the waters of an underground source as heretofore granted under Permit 66888, is issued subject to the terms and conditions imposed in said Permit 66888, and with the understanding that no other rights on the source will be affected by the change proposed herein. The well shall be equipped with a 2-inch opening and a totalizing meter must be installed and maintained in the discharge pipeline near the point of diversion and accurate measurements must be kept of water placed to beneficial use. The totalizing meter must be installed before any use of the water begins or before the proof of completion of work is filed. If the well is flowing, a valve must be installed and maintained to prevent waste. This source is located within an area designated by the State Engineer pursuant to NRS 534.030. The State retains the right to regulate the use of the water herein granted at any and all times.

This temporary permit does not extend the permittee the right of ingress and egress on public, private or corporate lands.

The issuance of this temporary permit does not waive the requirements that the permit holder obtain other permits from State, Federal and local agencies.

The total combined duty of water under Permit 16034, Certificate 5648; Permit 29299, Certificate 9541; Permit 30447, Certificate 9886; Permit 68715, and Temporary Permits 74229T, 74230T, and 74231T shall not exceed 928.0 acre-feet per year.

This temporary permit is issued pursuant to the provisions of NRS 533.345 Section 2 and will expire on August 2, 2007 at which time all rights herein granted shall revert to the right being changed by this temporary permit.

The amount of water to be changed shall be limited to the amount which can be applied to beneficial use, and not to exceed 1.7 cubic feet per second, or 319.0 acre-feet per year, and not to exceed an annual duty of 4.0 acre-feet per acre of land irrigated from any and/or all sources.

Work must be prosecuted with reasonable diligence and be completed on or before:


