The applicant **Erik M. Taylor and Kristine W. Taylor** hereby makes application for permission to change the **Point of Diversion and the Place of Use of a portion of** of water heretofore appropriated under **Permit No. 21447, Cert. 7481**

1. The source of water is **Underground**
2. The amount of water to be changed **0.43 cfs** **125.84 acre feet annually**
3. The water to be used for **Irrigation and Domestic**
4. The water heretofore permitted for **Irrigation and Domestic**
5. The water is to be diverted at the following point **NE $\frac{1}{4}$ SW $\frac{1}{4}$ of Section 9, T.34 N., R.45 E., M.D.B.& M., at a point from which the South $\frac{1}{4}$ corner of said Section 9, bears S 43° 22' 07" E, 1917.79 feet.**
6. The existing permitted point of diversion is located within **SE $\frac{1}{4}$ NE $\frac{1}{4}$ of Section 20, T.34 N., R.45 E., M.D.B.& M., at a point from which the East $\frac{1}{4}$ corner of said Section 20, bears S 75° 58' 00" E, 200.00 feet.**
7. Proposed place of use **The W $\frac{1}{2}$ of Section 9, T.34 N., R.45 E., M.D.B.& M. (31.46 acres within the described place of use)**
8. Existing place of use **Portions of the N $\frac{1}{2}$ of Section 20, T.34 N., R.45 E., M.D.B.& M., 31.46 acres irrigated 7.90 acres in the NW $\frac{1}{4}$ NW $\frac{1}{4}$, 7.89 acres in the SW $\frac{1}{4}$ NW $\frac{1}{4}$, 7.82 acres in SE $\frac{1}{4}$ NW $\frac{1}{4}$, 7.85 acres in NE $\frac{1}{4}$ NW $\frac{1}{4}$ Total of 31.46 acres to be removed from irrigation.**
9. Use will be from **January 1st to December 31st** of each year.
10. Use was permitted from **January 1st to December 31st** of each year.
11. Description of proposed works **Drilled well, pump motor and center pivot.**
12. Estimated cost of works **\$20,000.00**
13. Estimated time required to construct works **1 year**
14. Estimated time required to complete the application of water to beneficial use **1 year**
15. Remarks: **This application is for a temporary permit. This temporary permit is being applied for to allow the applicant to drill the well at the proposed point of diversion this fall.**

Once the well is drilled and the necessary diversion rate can be verified, we will file permanent applications to change this permit and portions of other permits controlled by the applicant to fully irrigate lands within the proposed place of use.

APPROVAL OF STATE ENGINEER

This is to certify that I have examined the foregoing application, and do hereby grant the same, subject to the following limitations and conditions:

This temporary permit to change the point of diversion and place of use of a portion of the waters of an underground source as heretofore granted under Permit 21447, Certificate 7481, is issued subject to the terms and conditions imposed in said Permit 21447, Certificate 7481, and with the understanding that no other rights on the source will be affected by the change proposed herein. The well shall be equipped with a 2-inch opening and a totalizing meter must be installed and maintained in the discharge pipeline near the point of diversion and accurate measurements must be kept of water placed to beneficial use. The totalizing meter must be installed before any use of the water begins or before the proof of completion of work is filed. If the well is flowing, a valve must be installed and maintained to prevent waste. This source is located within an area designated by the State Engineer pursuant to NRS 534.030. The State retains the right to regulate the use of the water herein granted at any and all times.

This temporary permit does not extend the permittee the right of ingress and egress on public, private or corporate lands.

The total combined duty of water under Temporary Permits 74414T and 74415T shall not exceed 125.84 acre-feet annually for the irrigation of 31.46 acres within the described place of use.

The issuance of this temporary permit does not waive the requirements that the permit holder obtain other permits from State, Federal and local agencies.

This temporary permit is issued pursuant to the provisions of NRS 533.345 Section 2 and will expire on August 2, 2007 at which time all rights herein granted shall revert to the right being changed by this temporary permit.

(PERMIT TERMS CONTINUED)

The amount of water to be changed shall be limited to the amount which can be applied to beneficial use, and not to exceed 0.43 cubic feet per second, not to exceed 125.84 acre-feet annually, and not to exceed a yearly duty of 4.0 acre-feet per acre of land irrigated from any and/or all sources.

Work must be prosecuted with reasonable diligence and be completed on or before:
