APPROVAL OF STATE ENGINEER

This is to certify that I have examined the foregoing application, and do hereby grant the same, subject to the following limitations and conditions:

This permit is issued subject to existing rights. It is understood that the amount of water herein granted is only a temporary allowance and that the final water right obtained under this permit will be dependent upon the amount of water actually placed to beneficial use. It is also understood that this right must allow for a reasonable lowering of the static water level. This well shall be equipped with a two (2) inch opening for measuring depth to water. If the well is flowing, a valve must be installed and maintained to prevent waste. A totalizing meter must be installed and maintained in the discharge pipeline near the point of diversion and accurate measurements must be kept of water placed to beneficial use. The totalizing meter must be installed before any use of water begins or before the proof of completion of work is filed. The State retains the right to regulate the use of the water granted herein at any and all times.

This permit does not extend the permittee the right of ingress and egress on public, private or corporate lands.

The issuance of this permit does not waive the requirements that the permit holder obtain other permits from State, Federal and local agencies.

The point of diversion and place of use are as described on the submitted application to support this permit.

The amount of water to be appropriated shall be limited to the amount which can be applied to beneficial use, and not to exceed 4.5 cubic feet per second or 1,280.0 acre-feet annually, but not to exceed 4.0 acre-feet per acre from all sources.

Work must be prosecuted with reasonable diligence and proof of completion of work shall be filed on or before:

June 13 2016

Water must be placed to beneficial use and proof of the application of water to beneficial use shall be filed on or before:





The applicant **Duck Flat Ranch, LLC**, a Nevada limited liability company hereby makes application for permission to appropriate the public waters of the State of Nevada, as hereinafter stated.

1. The source of the proposed appropriation is **Underground**
2. The amount of water applied for is **4.5 cfs, not to exceed 1280 Acre-Feet Annually**

6. Place of Use **Tract 37, Tract 38, Tract 42, portion of Tract 44, portion of Tract 45, Tract 55, Tract 57, Tract 59 consisting of portions of Sections 1, 2, 3, 10, 11, 12, 13, 14 & 15 along with Lot 1, Section 11, Lots 5 & 6, Section 12, Lots 1, 2, 3, 4, & 6, Section 14, all in T.36N., R.18E., M.D.B.&M.**
7. Use will begin about **January 1** and end about **December 31** of each year.
8. Description of proposed works **drilled and cased well equipped with a motor, pump, meter, pipeline and irrigation system**
9. Estimated cost of works **\$65,000.00**
10. Estimated time required to construct works **Four (4) years**
11. Estimated time required to complete the application of water to beneficial use **Eight (8) years**
