The applicant **Buffalo Valley Farms, LLC** hereby makes application for permission to appropriate the public waters of the State of Nevada, as hereinafter stated.

1. The source of the proposed appropriation is **an underground source (74469)**
2. The amount of water applied for is **6.0 c.f.s. – 1,280 acre-feet/acre**
  - (a) If stored in reservoir give number of acre-feet
3. The water to be used for **irrigation and domestic purposes**
4. If use is for:
  - (a) Irrigation, state number of acres to be irrigated **320 acres**
  - (b) Stockwater, state number and kinds of animals to be watered
  - (c) Other use (describe fully under No. 12. "Remarks")
  - (d) Power:
    - (1) Horsepower developed
    - (2) Point of return of water to stream
5. The water is to be diverted from its source at the following point **within the NE ¼ of the NE ¼ of Section 25, T.31N., R.41E., M.D.M., or at a point from which the NW section corner of Section 27, T.31N., R.41E., bears North 86°17' West a distance of 15,177.90 feet (74469).**
6. Place of Use **within the E ½ of Section 25, T.31N., R.41E., M.D.M.**
7. Use will begin about **January 1** and end about **December 31** of each year.
8. Description of proposed works **Drilled and cased well, equipped with motor, pump, pipeline, flow meter and center pivot irrigation irrigation system.**
9. Estimated cost of works **\$100,000.00**
10. Estimated time required to construct works **Three (3) years**
11. Estimated time required to complete the application of water to beneficial use **Eight (8) years**
