APPROVAL OF STATE ENGINEER

This is to certify that I have examined the foregoing application, and do hereby grant the same, subject to the following limitations and conditions:

This permit to change the point of diversion and manner of use of the waters of an underground source as heretofore granted under Permit 60896, Certificate 15245 is issued subject to the terms and conditions imposed in said Permit 60896, Certificate 15245 and with the understanding that no other rights on the source will be affected by the change proposed herein.

Monthly records shall be kept of the amount of water pumped from this well and the records submitted to the State Engineer on an annual basis within 30 days after the end of each calendar year.

The total combined duty of water under Permit 28088, Certificate 8435, Permit 29143, Certificate 10666, Permits 74730, 74731 and 74732 is limited to 1212.0 acre feet annually for the irrigation of 303.0 acres.

This permit does not extend the permittee the right of ingress and egress on public, private or corporate lands.

The total combined duty of water under Permit 28087, Certificate 8434, Permit 28088, Certificate 8435, Permit 29143, Certificate 10666, Permit 30898, Certificate 10671, Permits 65337, 74725, 74726, 74727, 74728, 74729, 74730, 74731, 74732, 74733, 74734, 74735, and 74736 shall not exceed 4126.0 acre-feet annually for the irrigation of 1031.50 acres.

The issuance of this permit does not waive the requirements that the permit holder obtain other permits from State, Federal and local agencies.

The point of diversion and place of use is as described under items 5 & 7 respectively on the submitted application to support this permit.

The amount of water to be changed shall be limited to the amount which can be applied to beneficial use, and not to exceed 0.226 cubic feet per second, or 68.0 acre-feet annually, and not to exceed a yearly duty of 4.0 acre-feet per acre of land irrigated from any and/or all sources.

Work must be prosecuted with reasonable diligence and proof of completion of work shall be filed on or before:

June 26, 2008

Water must be placed to beneficial use and proof of the application of water to beneficial use shall be filed on or before:

June 26, 2009

Map in support of proof of beneficial use shall be filed on or before:

June 26, 2009

The applicant **Sonterra Development Company, LLC** hereby makes application for permission to change the **Point of Diversion and Manner of Use** of water heretofore appropriated under **Permit No. 60896 (Cert. No. 15245)**

1. The source of water is **Underground (Well #4)**
2. The amount of water to be changed **0.226 c.f.s., but not to exceed 68 acre- feet annually**
3. The water to be used for **Irrigation**
4. The water heretofore permitted for **Irrigation and Domestic**
5. The water is to be diverted at the following point **NW¼ SE¼ of Section 13, T.30N., R.22E., M.D.B.&M., or at a point from which the S¼ corner of said Section 13 bears S. 0°11'50" W., a distance of 2,635.5 feet.**
6. The existing permitted point of diversion is located within **SW¼ NE¼ of Section 13, T.30N., R.22E., M.D.B.&M., or at a point from which the S¼ corner of said Section 13 bears S. 17°36'34" W., a distance of 2,927.20 feet.**
7. Proposed place of use **Unchanged**
8. Existing place of use **NE¼NE¼ (17 ac.) of Section 13, T.30N., R.22E., M.D.B.&M. Refer to PBU map filed under Permit No. 60896, (Cert. 15245) for existing place of use.**
9. Use will be from **January 1 to December 31** of each year.
10. Use was permitted from **January 1 to December 31** of each year.
11. Description of proposed works **Existing drilled and cased well complete with motor pump and meter completed with Permit No. 28088**
12. Estimated cost of works **Completed – See Permit No. 28088**
13. Estimated time required to construct works **Completed – See Permit No. 28088**
14. Estimated time required to complete the application of water to beneficial use **Four (4) years**
