APPROVAL OF STATE ENGINEER

This is to certify that I have examined the foregoing application, and do hereby grant the same, subject to the following limitations and conditions:

This permit to change the point of diversion and place of use of a portion of the waters of an underground source as heretofore granted under Permit 28032, Certificate 8763, is issued subject to the terms and conditions imposed in said Permit 28032, Certificate 8763 and with the understanding that no other rights on the source will be affected by the change proposed herein.

This permit does not extend the permittee the right of ingress and egress on public, private or corporate lands.

The total combined duty of water under Permit 56716, Certificate 13744; Permit 56717, Certificate 13745; Permits 73657, 74900 and 74901 shall not exceed 921.20 acre-feet.

The issuance of this permit does not waive the requirements that the permit holder obtain other permits from State, Federal and local agencies.

The point of diversion and place of use are as described on the submitted application to support this permit.

The amount of water to be appropriated shall be limited to the amount which can be applied to beneficial use, and not to exceed 0.25 cubic feet per second or 87.12 acre-feet seasonally and not to exceed a seasonal duty of 4.0 acre-feet per acre of land irrigated from any and/or all sources.

Work must be prosecuted with reasonable diligence and proof of completion of work shall be filed on or before: January 8, 2009
Water must be placed to beneficial use and proof of the application of water to beneficial use shall be filed on or before: January 8, 2011
Map in support of proof of beneficial use shall be filed on or before: January 8, 2011

The applicant **Joan E. Weinreich & Deborah L. Wohle** hereby make application for permission to change the **Point of Diversion and Place of Use and Manner of Use of a portion of water heretofore appropriated under Permit #28032 (Certificate #8763)**

1. The source of water is **Underground**
2. The amount of water to be changed **0.25 c.f.s. (87.12 acre-feet per year)**
3. The water to be used for **Irrigation**
4. The water heretofore permitted for **Irrigation**
5. The water is to be diverted at the following point **within the SW¼SW¼ Section 3, T.24N, R.41E., M.D.M. from which the SW corner of said section 3 bears S.35°49'W., 131.89 ft. dist.**
6. The existing permitted point of diversion is located within **the SE¼NE¼ Sec. 10, T.24N., R.40E., M.D.M. from which the E¼ corner of said Sec. 10 bears S.52°36'E., 114.95 ft. dist.**
7. Proposed place of use **W½ Sec. 3 T.24N., R.41E., M.D.M. (21.78 acres)**
8. Existing place of use **portions of N½ Sec. 10 T.24N., R.40E., M.D.M. (21.78 acres)**
9. Use will be from **January 1 to December 31** of each year.
10. Use was permitted from **February 15 to November 15** of each year.
11. Description of proposed works **drilled and cased well, line shaft pump and electric motor, with pipeline to sprinkler system (existing works).**
12. Estimated cost of works **\$40,000.00**
13. Estimated time required to construct works **two years**
14. Estimated time required to complete the application of water to beneficial use **4 years**
15. Remarks: **Applicants have purchased additional water rights in quantity sufficient to complete a designed irrigation system to support 2 full-circle center pivot structures.**
