The applicant **John L. Gagne and Monica Gagne and Wayne Morehouse and Linda Morehouse** hereby make application for permission to change the **Point of Diversion and Place of Use of a portion** of water heretofore appropriated under **Permit No. 55027**

1. The source of water is **underground**
2. The amount of water to be changed **0.177 cfs, 41.95 acre feet annually**
3. The water to be used for **Irrigation and domestic**
4. The water heretofore permitted for **Irrigation and domestic**
5. The water is to be diverted at the following point **within the SE ¼ of the NE ¼ of Section 31, T.12N., R.24E., M.D.M., or at a point from which the northeast corner of said Section 31 bears North 41°27'08" East a distance of 1882.25 feet. See map accompanying this application.**
6. The existing permitted point of diversion is located within **the NE ¼ of the NW ¼ of Section 31, T.12N., R.24E., M.D.M., from which point the northeast corner of said Section 31 bears North 75°51'45" East 2814.62 feet distance. See map supporting Permit Nos. 55027 & 55028.**
7. Proposed place of use **18.68 acres within the SW ¼ of the NE ¼ and the SE ¼ of the NE ¼ of Section 31, T.12N., R.24E., M.D.M., within Lyon County Assessor's Parcel Number 010-160-14., the exact location to be determined upon Proof of Beneficial Use. See map accompanying this application.**
8. Existing place of use **18.68 acres within the NE ¼ of the NW ¼ of Section 31, T.12N., R.24E., M.D.M.. A portion of Lyon County Assessor's Parcel No. 010-180-04. See map accompanying this application.**
9. Use will be from **January 1 to December 31** of each year.
10. Use was permitted from **January 1 to December 31** of each year.
11. Description of proposed works **Drilled well, motor, pump and pipeline irrigation system.**
12. Estimated cost of works **\$50,000.00**
13. Estimated time required to construct works **3 years**
14. Estimated time required to complete the application of water to beneficial use **5 years**

15. Remarks: Water in Permit No. 55027 is co-mingled with that in Permit No. 55028. Proportionate amounts of the diversion rate and duty stripped under each permit comprise and aggregate total of 0.413 cfs and 74.72 acre feet annually for irrigation on 18.68 acres of land within the Proposed Place of Use.

APPROVAL OF STATE ENGINEER

This is to certify that I have examined the foregoing application, and do hereby grant the same, subject to the following limitations and conditions:
This permit to change the point of diversion and place of use of a portion of the waters of an underground source as heretofore granted under Permit 55027, is issued subject to the terms and conditions imposed in said Permit 55027, and with the understanding that no other rights on the source will be affected by the change proposed herein. The well shall be equipped with a 2-inch opening and a totalizing meter must be installed and maintained in the discharge pipeline near the point of diversion and accurate measurements must be kept of water placed to beneficial use. The totalizing meter must be installed before any use of the water begins or before the proof of completion of work is filed. If the well is flowing, a valve must be installed and maintained to prevent waste. This source is located within an area designated by the State Engineer pursuant to NRS 534.030. The State retains the right to regulate the use of the water herein granted at any and all times.

This permit does not extend the permittee the right of ingress and egress on public, private or corporate lands.

The total combined duty of water under Permits 74982, 74983 and 74984 shall not exceed 112.22 acre-feet annually.

The issuance of this permit does not waive the requirements that the permit holder obtain other permits from State, Federal and local agencies.

The amount of water to be changed shall be limited to the amount which can be applied to beneficial use, and not to exceed 0.177 cubic feet per second, or 41.95 acre-feet annually, and not to exceed a yearly duty of 4.0 acre-feet per acre of land irrigated from any and/or all sources.

Work must be prosecuted with reasonable diligence and proof of completion of work shall be filed on or before:

April 25, 2010

Water must be placed to beneficial use and proof of the application of water to beneficial use shall be filed on or before:

April 25, 2012

Map in support of proof of beneficial use shall be filed on or before:

April 25, 2012
