The applicant **Tonto Corp.** hereby makes application for permission to appropriate the public waters of the State of Nevada, as hereinafter stated. **November 20, 1992 in Nevada**

1. The source of the proposed appropriation is **Underground Well No. 6**
2. The amount of water applied for is **3.34 c.f.s. 1148.42 acre feet annually** second-feet.
 - (a) If stored in reservoir give number of acre-feet
3. The water to be used for **Irrigation and Domestic**
4. If use is for:
 - (a) Irrigation, state number of acres to be irrigated **317.06 acres**
 - (b) Stockwater, state number and kinds of animals to be watered

 - (1) Horsepower developed
 - (2) Point of return of water to stream
5. The water is to be diverted from its source at the following point **NE $\frac{1}{4}$ NE $\frac{1}{4}$, Section 16, T.38 N., R.39 E., M.D.B. & M., at a point from which the Northeast Corner of said Section 16 bears N 47° 06' 00" E, 98.50 feet.**
6. Place of Use **NE $\frac{1}{4}$, N $\frac{1}{2}$ SE $\frac{1}{4}$, portions of S $\frac{1}{2}$ SE $\frac{1}{4}$ of Section 16, T.38 N., R.39 E., M.D.B. & M.**
7. Use will begin about **January 1** and end about **December 31** of each year.
8. Description of proposed works **Drilled well, pump, motor, ditches or pipelines**
9. Estimated cost of works **\$10,000**
10. Estimated time required to construct works **drilled well with 16" hole 280 feet deep. Well is cased with 16" casing from 0 to 258 feet deep. No information available regarding pump and motor.**
11. Estimated time required to complete the application of water to beneficial use **5 years**

EXHIBIT A

The applicant recognizes that the State Engineer issued Order #832, Notice of Curtailment of Water Appropriation within the Designated Paradise Valley Ground Water Basin, on December 1, 1983. The language of the order specifically provides:

All applications filed after December 1, 1983, to appropriate underground water to irrigate additional land within the Designated Paradise Valley Ground Water Basin will be denied.

At the time the order was issued, underground water was appropriated for irrigating the lands under Certificate Nos. 4388, 4851, 5340, 5341, 5342, 6542, 8542, 9494, and 9495.

Consistent with the requirements of Order #832, this application though filed after December 1, 1983, does not request appropriation of underground water to irrigate additional lands within the Designated Paradise Valley Ground Water Basin, but rather seeks an appropriation to irrigate lands previously irrigated before December 1, 1983 under the valid Certificates listed above.
