APPROVAL OF STATE ENGINEER

This is to certify that I have examined the foregoing application, and do hereby grant the same, subject to the following limitations and conditions:

This permit to change the point of diversion of the waters of an underground source as heretofore granted under Permit 73558 is issued subject to the terms and conditions imposed in said Permit 73558 and with the understanding that no other rights on the source will be affected by the change proposed herein.

This permit does not extend the permittee the right of ingress and egress on public, private or corporate lands.

The total combined duty of water under Permits 75223, 75224, 75225, 75226, and 75227 shall not exceed 255.05 acre-feet annually.

The total combined duty of water under Permits 13959, 14458, 68981, 75223, 75224, 75225, 75226, and 75227, for the portion owned by PIV, LLC shall not exceed 285.65 acre-feet annually.

The total combined duty of water under Permits 13959, 14458, 68981, 75223, 75224, 75225, 75226, and 75227 shall not exceed 1600.0 acre-feet annually.

The issuance of this permit does not waive the requirements that the permit holder obtain other permits from State, Federal and local agencies.

If any water under this permit is cancelled, withdrawn, or any water is not put to beneficial use, it will revert to the groundwater source and not back to the base water right.

The issuance of Permit 75224 expires Temporary Permit 75220T.

The point of diversion and place of use is as described under items 5 and 7 respectively on the submitted application to support this permit.

The amount of water to be changed shall be limited to the amount which can be applied to beneficial use, and not to exceed 0.266 cubic feet per second, and not to exceed 103.8 acre-feet annually, and not to exceed a yearly duty of 5.0 acre-feet per acre of land irrigated from any and/or all sources.

Work must be prosecuted with reasonable diligence and proof of completion of work shall be filed on or before:

July 3, 2008

Water must be placed to beneficial use and proof of the application of water to beneficial use shall be filed on or before:

July 3, 2009

Map in support of proof of beneficial use shall be filed on or before:

July 3, 2009

1. The source of water is **underground**

4. The water heretofore permitted for **irrigation and domestic**
5. The water is to be diverted at the following point **In the Northwest Quarter (NW¼) of the Southwest Quarter (SW¼) of Section 4, T. 20 S., R. 53 E., M.D.M., or at a point from which the West Quarter (W¼) corner of said Section 4 bears N 13°19'43" W at a distance of 713.7 feet.**
