APPROVAL OF STATE ENGINEER

This is to certify that I have examined the foregoing application, and do hereby grant the same, subject to the following limitations and conditions:

This permit to change the place of use of the waters of an underground source as heretofore granted under Permit 65575 is issued subject to the terms and conditions imposed in said Permit 65575 and with the understanding that no other rights on the source will be affected by the change proposed herein.

Monthly records shall be kept of the amount of water pumped from this well and the records submitted to the State Engineer on a quarterly basis within 15 days after the end of each calendar quarter.

This permit does not extend the permittee the right of ingress and egress on public, private or corporate lands.

The total combined duty of water under Permits 76963, 76965, 76966, 76967, 76968, 76969, 76970, 76971, 76972, 76973 and 76974 shall not exceed 609.985 acre-feet annually.

The total combined duty of water from this well under Permits 76963, 76965, 76966, 76967, 76968, 76969, 76970, 76971, 76973 and 76974 shall not exceed 609.985 acre-feet annually.

The total combined duty of water under Permits 76973 and 76974 shall not exceed 38.725 acre-feet annually.

The issuance of this permit does not waive the requirements that the permit holder obtain other permits from State, Federal and local agencies.

The point of diversion and place of use are as described on the submitted application to support this permit.

The amount of water to be appropriated shall be limited to the amount which can be applied to beneficial use, and not to exceed 0.0745 cubic feet per second or 38.725 acre-feet annually.

Work must be prosecuted with reasonable diligence and proof of completion of work shall be filed on or before:

September 18, 2009

Water must be placed to beneficial use and proof of the application of water to beneficial use shall be filed on or before:

September 18, 2014

Map in support of proof of beneficial use shall be filed on or before:

September 18, 2014


