

This supplemental application is being filed in conjunction with Amended Applications 77577, 77579, 77609, 77610 and 77631 to relocate 38 acres of irrigation within the existing dairy system to the SE $\frac{1}{4}$ SW $\frac{1}{4}$ of Section 3 and to remove 38 acres of existing water rights within the expanded corral area. The total combined duty under all six proposed permits will not exceed 5.0 acre feet per acre as allowed under the supplemental base permits.
