#### APPROVAL OF STATE ENGINEER

This is to certify that I have examined the foregoing application, and do hereby grant the same, subject to the following limitations and conditions:

This permit to change the point of diversion, manner and place of use of a portion of the waters of an underground source as heretofore granted under Permit 65214 is issued subject to the terms and conditions imposed in said 65214 and with the understanding that no other rights on the source will be affected by the change proposed herein. The well shall be equipped with a 2-inch opening and a totalizing meter must be installed and maintained in the discharge pipeline near the point of diversion and accurate measurements must be kept of water placed to beneficial use. The totalizing meter must be installed before any use of the water begins or before the proof of completion of work is filed. If the well is flowing, a valve must be installed and maintained to prevent waste. This source is located within an area designated by the State Engineer pursuant to NRS 534.030. The State retains the right to regulate the use of the water herein granted at any and all times.

This permit does not extend the permittee the right of ingress and egress on public, private or corporate lands.

The water under Permits 77989, 77994, 77996, 77997, 77998, 77999 and 78001 is commingled and the total combined duty shall not exceed 3,415.6 acre-feet annually for the irrigation of a maximum of 853.90 acres within the 960 acre described place of use.

The total combined duty of water under Permits 77989, 77994, 77995, 77996, 77997, 77998, 77999, 78000, 78001 and 78002 shall not exceed 3,520 acre-feet annually for the irrigation of a maximum of 880 total acres.

The issuance of this permit does not waive the requirements that the permit holder obtain other permits from State, Federal and local agencies.

The point of diversion and place of use are as described on the submitted application to support this permit.

The amount of water to be appropriated shall be limited to the amount which can be applied to beneficial use, and not to exceed 4.32 cubic feet per second or 768.0 acre-feet annually, and not to exceed a yearly duty of 4.0 acre-feet per acre of land irrigated from any and/or all sources.

Work must be prosecuted with reasonable diligence and proof of completion of work shall be filed on or before:

September 1, 2011

Water must be placed to beneficial use and proof of the application of water to beneficial use shall be filed on or before:

September 1, 2013

Map in support of proof of beneficial use shall be filed on or before:

September 1, 2013

## Attachment 2: Miscellaneous Remarks

Change Applications to Existing Permit Numbers 22621, 22622, 65213, 65214, 65215, 69334, 69335, 69336, and 69434 are currently being filed with the State of Nevada Division of Water Resources. The duties of each individual permit, including acre-ft and cfs, are shown below:

The Permit Terms of Permit numbers 65213, 65214, 65215, 69334, 69335, 69336, and 69434 state "The total combined duty of water under Permits 22621, Certificate 7061; 22622, Certificate 7062; 65213, 65214, 65215, 69334, 69335, 69336 and 69434 shall not exceed 3,520 acre-feet annually for the irrigation of 880 acres." This statement is quoted from Application Number 69434, since it is the most recent Change Application. Based on the review of available documents the total combined duty, based on the original rights, is 4020 acre-ft, as outlined above.

Change Application numbers 65213, 65214, and 65215 moved 3,520 acre-ft of water to the 880 acre Proposed Place of Use stated in their respective Change Applications. Within portions of this 880 acre Proposed Place of Use there was an existing 500 acre-ft of rights, outlined in application numbers 22621 and 22622. Under these conditions, the proposed place of use being limited to 880 acres, it reduced the total amount of rights held by the applicant. We are requesting the reinstatement of the water reduced to the total amount of rights held by the applicant prior to issuance of permits number 65213, 65214, 65215, 69334, 69335, 69336, and 69434.

Therefore, one of the purposes of these applications is to regain the rights outlined above, and it is requested that the combined duty, in the terms of any future permits, be corrected to 4,020 acre-ft. In addition to the 960 acres shown in Attachment 1, an additional 320 acres is included in the Proposed Place of Use of other Change Applications in this submittal for a total of 1280 acres.

Also, the water associated with the Proposed Place of Use, as shown in Attachment 1, has a communal piping system so the water is comingled between applications within this place of use described. It is requested this statement be included with any associated Permits.
