This is to certify that I have examined the foregoing application, and do hereby grant the same, subject to the following limitations and conditions:

This temporary permit, to change the point of diversion, manner and place of use of a portion the waters of the Galena Creek as heretofore granted under Permit 58947, which changed the point of diversion and place of use of a portion of Claim 654, Truckee River Decree, is issued subject to the terms and conditions imposed in said decree and with the understanding that no other rights on the source will be affected by the change proposed herein. A suitable measuring device must be installed and accurate measurements of water placed to beneficial use must be kept.

This temporary permit does not extend the permittee the right of ingress and egress on public, private or corporate lands.

The issuance of this temporary permit does not waive the requirements that the permit holder obtain other permits from State, Federal and local agencies.

This temporary permit is issued pursuant to the provisions of NRS 533.345 Section 2 and will expire **December 31, 2009** at which time all rights herein granted shall revert to the right being changed by this temporary permit.

The issuance of this temporary permit expires Temporary Permit 76532T.




As in previous years, this water has been leased to Montreux Golf Club, Ltd. for irrigation of the golf course.
