#### APPROVAL OF STATE ENGINEER

This is to certify that I have examined the foregoing application, and do hereby grant the same, subject to the following limitations and conditions:

This permit to change the point of diversion and place of use of a portion of the waters of an underground source as heretofore granted under Permit 61062 is issued subject to the terms and conditions imposed in said Permit 61062 and with the understanding that no other rights on the source will be affected by the change proposed herein. The well shall be equipped with a 2-inch opening and a totalizing meter must be installed and maintained in the discharge pipeline near the point of diversion and accurate measurements must be kept of water placed to beneficial use. The totalizing meter must be installed before any use of the water begins or before the proof of completion of work is filed. If the well is flowing, a valve must be installed and maintained to prevent waste. This source is located within an area designated by the State Engineer pursuant to NRS 534.030. The State retains the right to regulate the use of the water herein granted at any and all times.

This permit does not extend the permittee the right of ingress and egress on public, private or corporate lands.

The issuance of this permit does not waive the requirements that the permit holder obtain other permits from State, Federal and local agencies.

This permit is limited to the irrigation of 10 acres within the described place of use.

The point of diversion and place of use are as described on the submitted application to support this permit.

The amount of water to be appropriated shall be limited to the amount which can be applied to beneficial use, **and not to exceed 0.504 cubic feet per second or 40.0 acre-feet annually.**

Work must be prosecuted with reasonable diligence and proof of completion of work shall be filed on or before:

January 19, 2012

Water must be placed to beneficial use and proof of the application of water to beneficial use shall be filed on or before:

January 19, 2013

Map in support of proof of beneficial use shall be filed on or before:

January 19, 2013

Applications to change the Point of Diversion and Place of Use (As Applicable)  
Under Permits 13378, Certificate 5182, Permit 57852, and Permit 61062  
Description of Proposed Project & Water Usage

There are three permits associated with the applicant's ownership. These permits are Permit 13378, Certificate 5182, Permit 57852, and Permit 61062. Permit 13378 is certificated for the irrigation of 10.0 acres, Permit 57852 is permitted for the irrigation of 86.9 acres and Permit 61062 is permitted for the irrigation of 30.93 acres for a total of 127.83 acres located within portions of the NW1/4 of Section 14, T.32 N., R.44 E., M.D.B. & M.

The place of use of permit 13378 is located in portions of the N1/2 NW1/4, and the place of use of Permits 57852 and 61062 is the same place of use and is located within portions of the NW1/4 and excludes the place of use of permit 13378.

The applicant's have determined that the lands currently being irrigated and the lands planned to be added to irrigation can all be irrigated from the well permitted under Permit 57852 which will require filing these change applications to the planned point of diversion. In addition, with the configuration of the current places of use under the existing permits, the existing and planned irrigated areas will not match the existing places of use necessitating filing these change applications.

They have also decided to transfer 20 acres of permit 61062 to lands in Section 11, T.32 N., R.44 E., M.D.B. & M. Of these 20 acres, 10 acres will be irrigated from the well under Permit 61062 and the place of use of these 10 acres will be within the W1/2 SW1/4 of Section 11. The remaining 10 acres will be irrigated within the E1/2 SW1/4 of Section 11 from the well located on the said E1/2 SW1/4 of Section 11. The property associated with these 20 acres is owned by the children of the applicants. Once the new permits are issued, reports of conveyance will be filed to update title to these portions of Permit 61062. In addition the land where the well under Permit 61062 is located will be deeded to the child irrigating the 10 acres from this well.

In summary the change applications and description of the project will be as follows:

- 1) Change the point of diversion and place of use of Permit 13378. The point of diversion will be the same as Permit 57852 and the place of use will be the same as changes filed under Permit 61062 and Permit 57852. The well under Permit 13378 has been plugged as shown in the files of the Division of Water Resources. (Total of 107.83 ac. co-mingled within new place of use.)
- 2) Change the place of use of 57852. The place of use will be the same as changes filed under Permit 13378 and Permit 61062. (Total of 107.83 ac. co-mingled within new place of use.)
- 3) Change the point of diversion and place of use of 10.93 acres under Permit 61062. The point of diversion will be the same as Permit 57852 and the place of use will be the same as changes filed under Permit 13378 and Permit 57852. (Total of 107.83 ac. co-mingled within new place of use.)
- 4) Change the point of diversion and place of use of 10 acres under Permit 61062 to the E1/2 SW1/4 of Section 11.
- 5) Change the place of use of 10 acres under Permit 61062 to the W1/2 SW1/4 of Section 11.
