I intend to put down a well on my own property with a submersible pump which will allow me to irrigate my fields with a Wheel Line as needed.

At the present time, I have 40 acre feet of water coming from a well approximately 1000' from my property and 1800' from proposed new well site. Since 1972 water from this well has ran into a cement ditch owned by the Alamo Irrigation Co. I bought these 10 acres in November 2003 and have continued using the ditch to water since that time of purchase. As of
