Question 12:

This application and any others filed in this basin by Washoe County are to appropriate all of the unappropriated groundwater. The 20-yr average consumptive use will not exceed the perennial yield of the groundwater basin. This water will be co-mingled with other waters appropriated by Washoe County to serve a county-wide population of 500,000 by the year 2030.

Question 13:

Applicant hereby files these provisional Groundwater Applications with the State Engineer for the hydrologic basins 016 & 021 ("Provisional Applications") and does so without waiving or in any way prejudicing any priority, rights, privileges or entitlements associated with Applicant's previously filed Groundwater Applications, Application Numbers 63992 through 64009 filed with the State Engineer for the hydrologic basins 016 & 021 ("Previously Filed Applications"). Furthermore, Applicant's filing of these Provisional Applications shall not constitute an abandonment of any such priority, rights, privileges or entitlements that Applicant may have in any Previously Filed Applications in that hydrologic basin.
